Frank Caruso, owner and partner of Big Bear's new Sessions Retreat and Hotel, discussed the extensive remodel and vision of the former Wolf Creek Lodge. Caruso expressed the importance of integrating into the community as a business owner and resident. Sessions recently hosted the community's first Bear Crawl, a pub crawl fundraiser, in The Village to benefit Big Bear Alpine Zoo and a local family. Caruso's professional experience includes management and operations in hospitality in the San Diego area.

Darren Lane, manager of Black Forest Lodge, has successfully upgraded the reputation of the lodge over the years and has experienced the highs and lows of business during Big Bear's peak and shoulder seasons. Lane expressed that small business owners paying TBID want to better see VBB's value to them and where the marketing efforts are directed during slower/off-peak periods.
