RE: Health and Safety Plan (Version 2.1) Notice of Acceptance

Dear Mr. Cassulo:

On March 27, 2024, the U.S. Environmental Protection Agency ("EPA") received the Health and Safety Plan – Elevated Temperature Landfill Operation Areas, dated March 15, 2024 (Version 1.0) (the "Plan"), submitted by Chiquita Canyon, LLC ("CCL") pursuant to Paragraph 25 of the Unilateral Administrative Order, EPA Docket No. RCRA 7003-09-2024-0001 and CERCLA 106-09-2024-05, In the Matter of Chiquita Canyon, LLC, issued February 21, 2024 (the "UAO").

On April 24, 2024, Steve Cassulo and Nicole Ward, on behalf of CCL, Todd Shift, as Safety Representative, and David Matthews, as Incident Commander of the Response Multi-Agency Coordination Group ("RMAC"), signed the Health and Safety Plan for Elevated Temperature Landfill Operation Areas, dated April 16, 2024 (Version 1.1) (the "Revised Plan"), which superseded the Plan.

On July 3, 2024, and July 5, 2024, respectively, Steve Cassulo and Nicole Ward, on behalf of CCL, and David Matthews, as Incident Commander of the RMAC, signed the ETLF Operations HASP, dated July 3, 2024 (Version 2.1) (the "Second Revised Plan"), which superseded the Revised Plan.

EPA has reviewed the Second Revised Plan; and, in accordance with Paragraph 31 of the UAO, approves the Second Revised Plan as the Health and Safety Plan under Paragraph 25 of the UAO.
