- 11/3/25 –Notified South Coast Air Quality Management District ("South Coast AQMD") of procurement, completion of installation, and commencement of operation of remote monitoring units pursuant to Condition 75(a) of the Stipulated Order for Abatement in Case No. 6177-4 ("SOFA").
