**Re: Chiquita Canyon, LLC's Weekly Leachate Inspection Report for Stipulated Order for Abatement (Case No. 6177-4), Condition 27(c)**

All:

Pursuant to Condition 27(c) of the Stipulated Order for Abatement with the South Coast Air Quality Management District in Case No. 6177-4 (the “Order”), Chiquita Canyon, LLC (“Chiquita”) encloses a compilation of the twice daily leachate seep inspection logs for the dates of December 8, 2025 through December 14, 2025. No leachate seepage or pooling was observed within the Reaction Area of the Chiquita Canyon Landfill during these inspections.

Out of an abundance of caution and in an effort to be transparent, Chiquita is providing notice that a seep was observed on December 9, 2025 at approximately 2:00 p.m. in Grid 60, which is outside the Reaction Area as defined in Condition 9(a) of the Order and therefore outside the area required to be inspected under Condition 27. The seep was most likely rain water discolored due to fresh mulch. The seep was present for one hour and had approximately 1-5 gallons of leachate. Chiquita contained the seep by adding fresh dirt and track walking the slope. No other seepage or pooling was observed within, or outside, the Reaction Area that day or later in the week.

There is no additional information to provide under Condition 27(c).
