

## A Resolution to Reinstate the Civilian Conservation Corps

1. Whereas, there continues to be a rise in unemployment nationwide, and;
2. Whereas, this unemployment continues to be a drain on both the state and national
3. economy, and
4. Whereas, there are national disasters occurring annually from forest fires to flood to
5. weather related issues such as tornadoes and hurricanes, and:
6. Whereas, reinstating the Civilian Conservation Corps (CCC) would provide states
7. with individuals to help in times of distress.
8. Therefore, be it resolved by the Student Congress here assembled that the United
9. States Congress must reestablish the CCC.

## A Resolution to Delay the Implementation of Common Core

1. WHEREAS, the Common Core currently faces much opposition from both Republicans
2. and Democrats, and has not been clearly defined for the states, and
3. WHEREAS, Common Core has estimated costs of \$16-30 billion and has not yet been
4. adequately funded so that the burden will fall primarily on school districts, state, and
5. local governments, and
6. WHEREAS, the costs of the textbooks, computers, software, e-books and teacher training
7. issues must be solved before Common Core is implemented; now, therefore, be it
8. RESOLVED, that Common Core be delayed until the spring of 2017.

## A Bill to Ban 'Off Reservation' Gaming

SECTION 1: Section 20 of the Indian Gaming Regulatory Act (25 U.S.C. 2719) is amended to state that gaming shall not be conducted on land taken into trust after October 17, 1988, by the United States for the benefit of an Indian tribe unless the Secretary determines:

- a. that an Indian tribe demonstrates a substantial, direct, modern connection to land taken into trust as of October 17, 1988. The Secretary shall certify that the land is located within a 25-mile radius of the tribal headquarters or other tribal governmental facilities of the Indian tribe on the reservation;
- b. the Indian tribe has demonstrated a temporal connection to, or routine presence on, the land during the period beginning on October 17, 1988, and ending on the date of the certification; and
- c. or if the Indian tribe does not have a reservation, the land is located within a 25-mile radius of an area in which a significant number of members of the Indian tribe reside.

SECTION 2: This legislation shall take effect on January 1, 2015.

SECTION 3: All laws in conflict with this legislation shall be declared null and void.

## A Bill to Try Military Cases of Sexual Assault in Criminal Courts

1. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED
2. SECTION 1: All military cases of sexual assault, defined as the forcing of another into
3. intimate physical contact against their will, are hereby tried in criminal courts.
4. SECTION 2: The United States Military, along with the United States Department of
5. Justice shall oversee this legislation.
6. SECTION 3: This law will take effect within 12 months of passage.
7. SECTION 4: At that time, unclosed cases shall be given 2 months in which to reach a
8. verdict.
9. SECTION 5: All laws in conflict with this legislation are hereby declared null and void.
