### **Impromptu Speaking**

The Student will have 3 minutes to prepare and devise and 5 minutes deliver an impromptu speech about a topic that they draw at the beginning of the round.

This speech should highlight the student's ability to organize her/his thoughts in a logical manner while selecting creative and practical means to support their claims and interpretation of the topic or quote given.

## **Original Oratory:**

OO comprises of 10 minutes for Jr & High school, 5 minutes for elementary of memorized orations actually composed by the contestants and not used by them during a previous contest season. No minimum time is mandated, and no visual aids are permitted. Any appropriate subject may be used, but the orator must be truthful. Any non-factual reference, especially a personal one, must be so identified. Not more than 150 words of the oration may be direct quotation from any other speech or writing and such quotations must be identified in a printed copy of the oration supplied prior to registration. Extensive paraphrasing from other sources is prohibited. Please refer to the NFL (NSDA) rules for more information.

#### **Extemporaneous Speaking**

ES delves into current issues in the current school year. Thirty minutes before the contest is to begin, the speaking will draw 3 questions from a pool of pre-written questions, choose one, and return the other two. The other contestants draw in like manner, in the order of speaking, at intervals of seven minutes. A contestant drawing a question on which s/he has spoken previously in the tournament must return it and draw again. Each contestant will have 30 minutes to prepare during which s/he may consult any resources brought with them. At the end of the prep time, s/he will have a total of 7 minutes to present his/her speech. Please refer to the NFL (NSDA) rules for more information.
