Transportation: Public transportation is available from the Denver International Airport, to the tournament hotel, to the competition venue via the RTD Denver light-rail. A ticket good for a full day's use usually costs about \$8-10. The airport fare is separate. A word of advice: don't risk an expensive fine! They will check for your ticket in all likelihood.
