All Speech events and Legislative Debate will be held at Capital High School (100 Valley Drive).

Entry Deadline: Preliminary registration is due no later than 4:00pm on Monday, November 20th. Adds will be accepted until Monday, November 27th at 5pm. Drops and name changes to registration will be accepted electronically on the website until Thursday, November 30th at NOON. There will be no penalty fee for drops or changes up to Thursday, November 30th at NOON. <u>Fees:</u> Each entry will be charged \$5.00 (the charge will be \$10 for duo). Each school will also be charged a \$20 school fee. Any changes to your registration after Thursday, November 30<sup>th</sup> at Noon will be assessed a \$5.00 penalty; Any changes on Friday, December 1<sup>st</sup> will be assessed a \$20.00 penalty.

**Entries:** Schools may enter up to 4 entries in each event.
