

Round 1 – 2020 Debate #1 SCJFL Congress

A Resolution to Stop Deforestation on the Amazon Rainforest

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Whereas, Illegal deforestation is rapidly causing the Amazon rainforest to shrink and depriving natural habitats of animals, destroying Native Amazonian tribal lands, and also becomes a contributing factor of climate change;

Whereas, above 20 percent of the rainforest is already cut down and the rainforest is shrinking by 20,000 square miles each year;

Whereas, there are over 10 million species of animals already living in the Amazon rainforest, and an average of 137 species goes extinct every day;

Whereas, the Amazon rainforest provides 20% of the world's oxygen but is rapidly getting cut down;

Therefore, we should encourage Brazil, Bolivia, Peru, Ecuador, Colombia, Venezuela, Guyana, Suriname and French Guiana, to ban deforestation in the Amazon rainforest, whereas violators would be fined from \$1,000-\$2,000,000, and/or serve a sentence for up to 10 years.

Round 2 – 2020 Debate #1 SCJFL Congres

A Bill to Make Voting Mandatory

SECTION 1. Citizens shall be required to vote in every government election.

SECTION 2. This will apply to all citizens of America, no matter the gender, race, religion, creed or status. Failure to vote will result in a \$250 fine per offense.

SECTION 3. This bill will be enforced by the U.S. Election Assistance Commission

SECTION 4. This legislation shall take effect November 3, 2020

SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A BILL TO ABOLISH THE SAT

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

Section 1. The SAT (Scholastic Assessment Test), a nationwide test widely used for college admissions in the United States, will be abolished.

- A. Future highschoolers will not have to take the SAT to get into colleges after this bill is passed.
- B. The SAT will no longer be required for college application and will not be used to determine admission.

Section 2. The requirement will be applied to all colleges and universities in the US.

Section 3. The US Department of Education shall oversee the enforcement of this bill.

Section 4. This bill shall take effect after the conclusion of the 2020-2021 school year.

Section 5. All laws in conflict with this bill are hereby declared null and void.

A Bill to Close In-Person Schooling for the 2020-2021 School Year

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

SECTION 1: All Public and Charter Schools will not reopen and must use online classes for the 2020-2021 fall and spring semesters.

SECTION 2: All schools affected by this legislation will not be permitted to operate in-person classes. In addition, the United States Department of Education will provide funds to any school in need of funding to make the transition to online schooling.

SECTION 3: The US Department of Education shall oversee the enforcement and implementation of this bill.

SECTION 4: This legislation shall take effect immediately on the current/upcoming fall semester of 2020. SECTION 5: All laws in conflict with this legislation are hereby declared null and void.
