Legislation # 1

A Bill to Combat Climate Change

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The budget for the United States Environmental Protection Agency will be increased
3 from \$6.658 Billion to \$15.5 Billion to research how to and act in order to combat
4 climate change and the threats climate change impose on Americans, wildlife, and the
5 environment.

6 SECTION 2. Combating climate change can be defined as any and all research and actions taken to
7 protect human health and the environment from the increasing dangers of global
8 warming.

9 SECTION 3. The United States Department of the Interior will oversee the increase in funding and the
10 United States Environmental Protection Agency will use the increase in funding to
11 combat climate change. A. Much of the increased funding shall be used to create a new
12 Climate Change Division.

13 SECTION 4. This legislation will take effect January 1, 2022.

14 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Prosecute Hate Crimes

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. As hate crimes across the country are on the considerable rise, the United State
3 Department of Justice will receive an extra \$1 billion to increase litigation funding to
4 prosecute hate crimes across the country.

5 SECTION 2. As defined by the United States Department of Justice, a prosecutable hate crime includes
6 acts of physical harm and specific criminal threats motivated by animus based on race,
7 color, national origin, religion, gender, sexual orientation, gender identity, or disability.

8 SECTION 3. The United State Department of Justice will oversee implementation of this bill. A. The
9 funding shall be used to increase the litigation funding of the Department of Justice to
10 more thoroughly prosecute hate crimes across the nation, especially in states without anti-
11 hate crime laws.

12 SECTION 4. This legislation will take effect January 1, 2022.

13 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Legalize Online Gambling

1 WHEREAS, Federal internet gambling laws currently are outdated and/or not comprehensive; and

2 WHEREAS, Some states including Delaware, Nevada, and New Jersey have legalized online
3 gambling while others including Hawaii and Utah have not, creating confusion and
4 murky legal standing; and

5 WHEREAS, Other forms of gambling such as casinos and lotteries are legal and taxable across the
6 nation; and

7 WHEREAS, Legalizing online gambling offers a damage-control approach which can be safer for
8 participants and offer taxes for local and state governments; now, therefore, be it

9 RESOLVED, That the Congress here assembled shall research and work to implement legal, taxable
10 online gambling to create safer online environments as well as a new revenue stream
11 from gambling taxes.

A Bill to Reduce Space Pollution

1 WHEREAS, Ongoing activity in space by countries and corporations across the globe continues to
2 pollute the Earth's orbit ; and

3 WHEREAS, There are estimates of more than 170 million small, 670,000 medium, and 29,000 larger
4 pieces of debris in orbit ranging from 1cm to entire satellites; and

5 WHEREAS, Falling Chinese space debris is expected to fall over the United States, hitting the Pacific
6 Ocean, and possibly damaging building; and

7 WHEREAS, Space pollution causes damage on Earth and can cause currently immeasurable amounts
8 of harm to the atmosphere; now, therefore, be it

9 RESOLVED, That the Congress here assembled shall fund a federal task force independent of other
10 space agencies to research possible damages as a result of space pollution as well as
11 means to mitigate the growing debris in orbit.

A Bill to Increase Police Accountability

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. All law enforcement officers who are fired or dismissed from posts must be evaluated by
3 independent auditors before being allowed to return to any form of service, regardless of
4 jurisdiction.

5 SECTION 2. Evaluation by arbitrators will decide whether the officer was wrongfully terminated or
6 the officer acted against policy and is unfit to serve in law enforcement.

7 SECTION 3. The United States Department of Justice will oversee enforcement of this bill. A. The
8 arbitration process wherein fired police officers can easily appeal their firing with little to
9 no accountability will be halted. B. Each team of auditors will be independent from any
10 police force, and will be made up of one retired police officer and one clinical
11 psychologist. C. If found unfit, the dismissed officer will be barred from employment by
12 any law enforcement agency across the country.

13 SECTION 4. This legislation will take effect January 1, 2022.

14 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Temporarily Release Patents on Certain COVID-19 Vaccines

1 BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

2 SECTION 1. The intellectual property rights of Pfizer and Moderna and other approved vaccines from
3 the World Health Organization will be waived when it comes to distributing the COVID-
4 19 vaccines across the globe.

5 SECTION 2. COVID-19 Vaccinations are defined as vaccines that are approved by the World Health
6 Organization to biologically provide active immunity to COVID-19.

7 SECTION 3. The United States Patent and Trademark Office as well as the United States Center for
8 Disease Control and Prevention will oversee the implementation of this bill. A. As Pfizer
9 and Moderna are corporations headquartered in the United States, the Patent and
10 Trademark Office will oversee the release of these patents to reputable laboratories
11 around the world. B. The Center for Disease Control will work in congruence with the
12 World Health Organizations to approve safe vaccines whose patents shall be distributed.

13 SECTION 4. This legislation will take effect January 1, 2022.

14 SECTION 5. All laws in conflict with this legislation are hereby declared null and void.

A Bill to Increase Transparency within Government

1 WHEREAS, Current partisan division among both politics and media continues to divide the country;
2 and

3 WHEREAS, This increased division between politicians and different (forms) of media leads to a lack
4 of reporting and thus transparency for the general public; and

5 WHEREAS, The case of Florida Governor Ron Desantis only allowing Fox News Media to film the
6 signing of State Senate Bill 90 demonstrates the partisan division between certain
7 politicians and certain media outlets; and

8 WHEREAS, Actions such as those from Governor Desantis limits government transparency and
9 infringes on the freedom of the press; now, therefore, be it

10 RESOLVED, That the Congress here assembled shall work to introduce legislation to mitigate the
11 partisanship that arises in media and government by enforcing fairer distribution of
12 reporting for multiple different media outlets.
