A Bill to Eradicate the Zealous Obtaining of the Silk-Stocking

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
- 2 Section 1: A marginal tax of 73% will be put on ordinary income
- 3 over \$10 million. A tax of 10% will be put on real estate
- 4 transactions above \$1 million. A 10% tax will be put on luxury
- 5 vehicles over \$70,000.
- 6 Section 2: Marginal tax is defined as an additional tax paid for
- 7 every additional dollar earned as income. Ordinary income is
- 8 defined as money gained that derives from short-term capital or
- 9 labor. A. Luxury vehicles will be defined as vehicles with
- 10 features that exceed the average necessities including but not
- 11 limited to additional performance capabilities and lavish
- 12 interiors. B. The IRS will have the authority to specify any
- 13 other tangible property as a "luxury vehicle" for these tax pur
- 14 poses.
- 15 Section 3: The Internal Revenue Service will oversee the
- 16 enforcement of this bill. A. \$75 billion will be given to the
- 17 Internal Revenue Service for necessary training, reporting
- 18 systems, hiring, and more that are needed to enforce this
- 19 bill. B. A 50% tax will be put on the net worth of any
- 20 taxpayer affected under this bill if they move to a different
- 21 country to avoid the new tax laws.
- 22 Section 4: This legislation will take effect on January 1, 2023.
- 23 Section 5: All laws in conflict with this legislation are hereby
- 24 declared null and void.

A Bill to Standardize Death Certificates

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
- 2 Section 1: All states in the United States of America must adhere
- 3 to the following for a standardized death certificate: A. A
- 4 death cannot be automatically marked as any current virus even
- 5 though it may have been a contributing factor on the death
- 6 certificate. B. If a person died from Covid, Part I of the
- 7 death certificate must only have Covid-19 as the primary cause
- 8 of death. Part II can be left blank or a different condition
- 9 can be written. However, if a deceased person had Covid-19 but
- 10 their primary cause was different, then Covid-19 should only be
- 11 written in Part II. If the cause of a person's death is
- 12 undetermined, then in Part I, "unknown death" can be written.
- 13 Medical Certifiers and hospitals must follow these procedures
- 14 for every deceased person.
- 15 Section 2: Part I of a death certificate is the chain of the
- 16 event(s) that caused the death. Part II of a death certificate
- 17 are other significant conditions that possibly could have
- 18 contributed to death but are not resulting in the underlying
- 19 cause given in Part I.
- 20 Section 3: The Department of Health and Human Services in coalition
- 21 with the Country Health Department will oversee the
- 22 implementation of this bill. If the medical certifier in
- 23 charge of writing the death certificate is caught mishandling
- 24 the report and is committing fraud, they will be suspended from
- work for 6 months.
- 26 Section 4: This bill will be implemented on February 1st, 2022.
- 27 Section 5: All laws in conflict with this legislation are hereby
- 28 declared null and void.

A Bill to Fund Supervised Injection Sites

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
- 2 Section 1: Supervised injection sites in the United States are
- 3 hereby legalized and given the funding of \$1.2 billion over the
- 4 next five years.
- 5 Section 2: Supervised injections sites are defined as places in
- 6 cities that would offer injection of illegal drugs safely to
- 7 addicts with sanitized needles and correct medical protocols,
- 8 and verified medical professionals and workers shall inject the
- 9 drugs using the correct dosage.
- 10 Section 3: The Department of Health and Human Services shall
- 11 enforce this legislation. A. The Department of Health and Human
- 12 Services shall set up the injection sites. B. There shall be no
- 13 less than 2 supervised injection sites per state. States that
- 14 fail to meet the minimum standards would receive a fine of \$1
- 15 million.
- 16 Section 4: This legislation will take effect on June 1st, 2022
- 17 Section 5: All laws in conflict with this legislation are hereby
- 18 declared null and void.

A Bill to Provide Funding for Veterans Suffering from Mental Illness Caused by Military Service

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
- 2 Section 1: A. Congress will allocate 270 billion dollars over the
- 3 next decade to fund the treatment of Veterans suffering from
- 4 PTSD or any other mental disorders resulting from their
- 5 military service. B. Registered veterans EACH will receive
- 6 checks of 4500 each year over the course of ten years depending
- 7 on the severity of their condition, for use of psychological
- 8 and or psychiatric sessions.
- 9 Section 2: The American Psychological Association defines PTSD as a
- 10 PTSD is an anxiety disorder caused by a traumatic event, such
- 11 as combat, a natural disaster or crime, or even a traffic
- 12 accident. It may affect personal relationships or health.
- 13 Section 3: The U.S. Department of Veterans Affairs and The
- 14 Department of Health And Human Services will oversee the
- 15 enforcement of this legislation. Funding will be allocated by
- 16 pulling directly from the Department of Defense's budget.
- 17 Section 4: This legislation will begin in FY 2023 and run until FY
- 18 2032.
- 19 Section 5: All laws in conflict with this legislation are hereby
- 20 declared null and void.

A Bill to Abolish the Senate Filibuster

- 1 BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
- 2 Section 1: The Senate Filibuster will be abolished entirely. Any
- 3 member of Congress who continues to use the filibuster after
- 4 this legislation has been passed will be censured. This bill
- 5 will apply to all of Congress.
- 6 Section 2: The Senate Filibuster shall be defined as a tactic used
- 7 by both parties to delay or prevent the vote on a bill,
- 8 resolution, or amendment. Censoring shall be defined as a
- 9 formal, public, group condemnation of an individual, often a
- 10 group member, whose actions run counter to the group's
- 11 acceptable standards for individual behavior. Members of
- 12 Congress who have been censured are required to give up any
- 13 committee chairs they hold.
- 14 Section 3: The U.S Senate Select Committee of Ethics as well as the
- 15 U.S Senate Committee on Rules and Administration will be
- 16 responsible for the implementation of this bill. A. Each party
- 17 will be allowed a 4 day time period to speak. B. This will
- 18 apply to the Senate.
- 19 Section 4: This legislation will take effect upon passage.
- 20 Section 5: All laws in conflict with this legislation are hereby
- 21 declared null and void.
