

Congressional Debate Legislation #1

**A Bill to Ban K-7 Tackle Football**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
2. Section 1 Tackle football programs for children in 7th grade or
3. younger will be banned. Any programs that would like to continue
4. will be required to switch to flag football.
5. Section 2 Tackle football has been deemed by the CDC Injury Center
6. as a high risk youth sport. A safer alternative for children on
7. the younger side is flag football. The ban is implemented for K-7
8. instead of K-8 in order for children to have experience before
9. going into high school.
10. Section 3 The Department of Health and Human Services will work
11. with the CDC Injury Center to oversee the enforcement of this
12. bill.
- A. The DHHS will make sure that any and all K-7 tackle
13. football programs will be shut down or switched to flag
14. football.
- B. This ban will be on a "three strike" punishment
15. system. On the first strike a letter will be sent out to the
16. league president requesting them to shut down their program
17. within one month The second strike will include a fine of up to
18. \$10,000. If a final strike is needed, the league president will
19. be charged \$50,000 and may be sued for child abuse.
20. Section 4 This legislation will take effect on January 1st, 2023.
21. Section 5 All laws in conflict with this legislation are hereby
22. declared null and void.

**A Bill to Promote Healthy Lunch Options**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:

2. Section 1 Schools will now be required to provide a mandatory salad  
3. bar in their lunch lines and focus their physical education  
4. curriculums on physical fitness.

5. Section 2 Mandatory salad bars shall be defined as sections of  
6. counter designated for healthy foods like salad, vegetables, and  
7. fruits.

8. Section 3 The Department of Education and Food and Drug  
9. Administration will oversee the implementation of this bill.

A.

10. The Department of Education will be responsible for distributing  
11. funds.

B. The Food and Drug Administration will be responsible  
12. for overseeing health regulations and making sure schools have  
13. an adequate amount of healthy foods in their salad bars.

C. Up

14. to a \$3,000 fine will be put in place for schools that do not  
15. comply. The amount will depend on their income.

16. Section 4 This legislation will take effect at the beginning of  
17. the 2023/2024 school year.

18. Section 5 All laws in conflict with this legislation are hereby  
19. declared null and void.

**A Bill to Eliminate College Tuition**

1. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED:
2. Section 1 All course tuition for two and four-year colleges and
3. technical schools in the United States is hereby eliminated.
4. Section 2 Four-year colleges shall be defined as an undergraduate
5. degree program that leads to a bachelor's degree in a specific
6. area of study. Technical schools shall be defined as a two-year
7. college that covers fields such as business, finance,
8. hospitality, tourism, construction, engineering, visual arts,
9. information technology and community work. Tuition shall be
10. defined as a sum of money charged for teaching or instruction by
11. a school, college, or university. Tuition does not include meal
12. plans, housing, or student fees.
13. Section 3 The Department of Education will oversee the
14. implementation of this bill.
15. Section 4 This legislation will take effect on August 1st, 2023.
16. Section 5 All laws in conflict with this legislation are hereby
17. declared null and void.
