## **Tournament Policies**

#### Entries

Registration will take place on forensicstournament.net. Registration will close on March 17, 2023.

Judge requirements are determined using the N-1 formula, where N = the number of teams you're entering. In other words, if you intend to enter 3 teams, they will need to be covered by 2 full-time judges. One uncovered team per school may be entered at an additional fee of \$100 (in addition to the entry fee).

The fee for each team at the tournament is \$40 to cover awards, custodial fees and breakfast in the morning.

#### Judges

As noted under Registration, you should register judges sufficient to cover your team entries using the N-1 formula. You should indicate whether each judge is qualified to Chair a deliberation panel upon registration. Generally, experienced, mature and confident judges should be designated as a Chair as they will have additional responsibilities in this tournament.

Chairs will serve one very important role in this tournament that differ substantially from judges' typical responsibilities:

Chairs are expected to manage Points of Privilege offered by the debaters. Points of Privilege are intended to allow debaters to address potentially-offensive behavior by others in the round. If a debater requests a Point of Privilege, the Chair should stop the speaker's time, allow the debater raising the point to state their concern and then respond either by counselling the speaker on more appropriate behavior, counselling the debater raising the point that their point is not valid or by deferring decision by taking the point "under advisement."

The tournament will NOT conduct open deliberation.

## **Equity**

The Western States Debating Championship is committed to preserving equity for all participants. Everyone in attendance, at all times through the duration of this tournament, is responsible for upholding equitable behavior. No attendee should face discrimination or harassment on the basis of race, gender identity, sexual orientation, or other protected characteristics.

While it is our hope that many equity questions can be addressed via points of personal privilege, the tournament will have a designated Lewis & Clark faculty equity officer (with experience in debate) who will facilitate the observance of this policy and who may be contacted to facilitate any concerns or complaints arising from potential violations. The tournament reserves the right to take concrete action ranging from warning to mediation to disqualification. A full equity policy will be released closer to the beginning of the tournament.

#### Locations

General Assembly will be in Evans Hall Auditorium; most, if not all, rounds will take place in JR Howard Hall. We recommend parking in lot "E" on the following map:
