GENERAL INFORMATION

ENTRIES: Register your entry by Wednesday, **January 14th at 5pm.**

1. Go to <https://forensictournament.net/FranklySpeakingTournament/26> to complete your entry
2. Click Login (if you have never used this site before, it will ask you to register)
3. Go through each tab and register your team

PARTICIPATION: Any regularly enrolled student is eligible to enter as many as six events; however, the participant may not enter more than three events from each grouping (one person may enter two duos in Group B as two of their three events).

There is no limit on entries per event; however, if a school enters more students than there are sections in any one event, the tournament director may place more than one student from the same school in the same section. **Triple entered students (TE) must sign in to all three events prior to the round. Judges will not be required to wait for students that have not signed in.**

FEES:

Individual Events: \$10.00 per individual event slot. One judge for every six individual event slots must be provided. A limited number of hired judges can be provided at the rate of \$12.00 per uncovered individual event slot.

IPDA Debate: IPDA slots are \$15 a debater with one judge covering two slots. A judge can be provided at the rate of \$40.00 dollars per uncovered debate slot. Change/drop fees range from \$10.00 to \$30.00 (see DEADLINES section). **Make all checks payable to Kacy Abeln.**

ELIMINATION ROUNDS: Preliminary rounds for individual events will be randomly paired. The six participants with the best rankings will advance to the open division final round. Standard tie breakers will be used. The six community college participants with the best rankings that have not advanced into open division finals will advance to the two-year college division finals; however, we will not advance more than half of the field of community college competitors into a final round. Again, standard tie breakers will be used. We will do our best to provide a full panel of three judges for all finals; however, if we have a limited number of judges available, community college finals may only be assigned one judge. Awards will be given to all participants advancing to a final round.

TEAM SWEEPSTAKES: There are three sweepstakes categories:

Overall Sweepstakes (IE and Debate) will recognize the top 3 teams (1st place receiving the **Lauren Morgan Open Division Sweepstakes Award**).

Open IE Sweepstakes will recognize the top 5 teams in Individual Events.

Community College Sweepstakes will recognize the top three community college teams in IE points (1st place receiving the **Jim Collie Community College Sweepstakes Award**).

Sweepstakes points earned in the community college division will not count in the open division. Sweepstakes points earned in the open division by a community college participant will count in the community college division.

THE JODIE BRIGGS INDIVIDUAL SWEEPSTAKES AWARD: A contestant must be entered into a minimum of any four events to qualify for individual sweepstakes, with IPDA counting as an event. Awards will be given to the top five overall students. The winners will be determined by the largest number of sweepstakes points earned for their team according to the

previously listed schedule. Entry in individual sweepstakes is the responsibility of the coach when making the entry.

FOOD: For those of you familiar with the Midwest, our chances of hosting in a winter wonderland is always a possibility. There are multiple options by campus, but if safety/difficulty become an issue we recommend the local Jimmy Johns (630-942-8480) for delivery.

DEADLINES: Changes/Drops should be made by the coach through **forensictournament.net** until **Thursday, January 15th at noon.**

Changes made after Noon on Thursday will incur a \$10.00 charge. A \$25.00 fee per slot will be charged for any drop made day of the tournament.

*A \$30 fee per dropped judge will be assessed for any judges dropped **after 9 p.m. CST on Thursday, January 15th**. A \$50.00 fee per dropped judge will be assessed for judges dropped the day of.

EVENT RULES: For individual events, Phi Rho Pi event descriptions will govern event operation. For complete information on the web, visit <http://www.phirhopi.org>.

In addition, four over-riding rules govern events:

1. All public events must be the original work of the contestant.
2. No speech or program, in part or in its entirety, may have been used by the contestant prior to September 2025.
4. College of DuPage will not be responsible for providing audiovisual or any other equipment or power sources for use during the tournament.

·Important Note 2: This is a single flighted tournament. If the tournament size becomes so large it requires double-flighting, coaches will be notified but Registration will still begin 9:15am.
