## **TOURNAMENT DETAILS**

**ENTRIES:** Please submit your squad's entries by Tuesday, December 2<sup>nd</sup> at 6:00 pm (Pacific time) to <a href="https://www.forensicstournament.net">www.forensicstournament.net</a>. A complete entry includes not only the teams competing, but also the names (and availability) for each judge, and a complete judging philosophy for each critic. The tournament will charge \$50.00 per team. There are no additional fees, since programs cannot enter uncovered teams. Payments can be made via check, or by using FTN's payment link.

**DIVISIONS:** The tournament will offer 5 rounds of NPDA-style debate. Novice, Junior and Senior divisions will be offered. Division specifics are:

- Novice division is open to any debaters in their first semester of competition. Competitors who have high school experience in debate or other formats of oral argumentation (e.g., Mock Trial, Model Congress, Model UN) should not be entered into novice division.
- Junior division is open to competitors who have competed, in any format of intercollegiate debate, for more than 3 semesters. This division is intended for debaters who are in their second year of intercollegiate debate competition.

It is our intent to maintain distinct divisions, whenever possible. However, if the number of entries makes a division is untenable, we will need to collapse it into another division.

**JUDGING:** Each program MUST cover all its entries. One full-time judge can cover two (2) NPDA teams. Debate judges are obligated for one elimination round past the elimination of their program's last team. All events will use e-ballots. Judges will need an email address or cell phone number where they can receive a link to their ballots, as well as a device with Internet access.

**PAIRINGS:** The first two round will be randomly matched. Subsequent rounds will be highlow power-matched. A limited number of judge strikes (approximately 15% of the judge pool) will be offered to schools whose judges have posted judging philosophies.

**TIE BREAKERS:** Teams will first be ranked by wins, followed by adjusted speaker points, total speaker points, opposition record and Z-Score. Per NPDA rules, brackets will be broken in elimination rounds.

**AWARDS:** The tournament will offer awards to both competitors and participating schools.

- **INDIVIDUALS:** All debaters advancing to elimination debates will receive an award. Additionally, the top 5 speakers in each division will be recognized. Awards will be mailed to winner during the week following the tournament.
- **SCHOOL:** The top 5 schools will be recognized, as well as the top 3 community college programs. Points are earned as follows:
  - Preliminary Rounds: Teams earn 2 points per preliminary round win. Each school's top four teams, regardless of division, will count toward school sweepstakes.
  - o *Elimination Rounds*: Teams earn 2 wins per elimination round win. Each school's top four teams, regardless of division, will count toward school sweepstakes.
