**From Recording to Revision: Using AI to Strengthen Round Vision**

Presenter: Iain Lambert

This session explores practical, responsible uses of AI to expand access to high-quality debate feedback within IPDA programs. Many large teams struggle with coach-to-student ratios, while smaller programs may lack experienced coaching support. The presentation demonstrates how competitors and coaches can use round recordings, transcripts, and structured prompting to generate constructive AI-assisted feedback modeled on IPDA judging norms. The session will also address adaptation across differing debate paradigms and discuss ethical guardrails for AI use. Drawing on emerging research in AI-assisted learning and communication coaching, the session emphasizes supplementation of coaching rather than replacement.

**Grow or Die: A Data-Driven Case for Expanding IPDA**

Despite years of rapid growth, participation in the IPDA is slowing. Historical examples show that college debate formats rarely remain on a plateau: they are growing, or they are declining. An analysis of IPDA data shows signs of the beginning of a decline phase. The IPDA must adapt on multiple fronts—digital presence and public image, active recruiting of institutions, and more—to continue its positive trajectory and avoid the fate of other debate formats.

**Resolved: Change is Inevitable in the IPDA**

The goal for this presentation is to have an open conversation about change and how it's approached in the IPDA. Presenters will explore historical precedence (creation of novice division, varsity, TIPDA, and finally JV) as well as changes that have occurred systemically that may not have been wanted, but occurred anyway, especially those that linger from the COVID era. They will also be surveying the general body of coaches and students to discuss changes they have seen since being on the circuit, and what changes they would like to see, in order to provide context of what future the IPDA holds.

**The Use of Esoteric Topics in Limited Prep Debate**

Given the nature of IPDA as a limited prep form of debate, the use of esoteric topics at IPDA tournaments can be potentially problematic. This panel will explore the desirability of esoteric topic use in IPDA tournaments and consider whether use of more "general knowledge" topics would be preferable. Subtopics will include burdens placed on coaches, competitors and judges as well as impacts in debate rounds in terms of "source pressing" and other evidentiary issues.
