

1. **A Bill to Mandate Cultural Education for Military Deployment**
- 2.
3. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
4. **SECTION 1:** The United States Federal Government shall create a new military department,
5. the “Defense Cultural Education Office,” (DCEO) to oversee mandatory cultural
6. education for military personnel prior to deployment to foreign territories.
7. **SECTION 2:** The Defense Cultural Education Office will fall under the oversight of the Office
8. of the Secretary of Defense (OSD). The OSD and the Bureau of Educational and
9. Cultural Affairs (of the State Department) will coordinate efforts to design the
10. curriculum and hire the staff of the new DCEO.
11. **SECTION 3:** This plan shall be implemented immediately upon passage.
12. **SECTION 4:** This program will be funded by redirecting .05% Department of Defense’s
13. budget.
14. **SECTION 5:** All laws and policies in conflict are hereby deemed null and void.

1. **A Bill to Fund Manned Space Exploration**

3. BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:
4. **SECTION 1.** The United States Federal Government shall hereby fund the National
5. Aeronautics and Space Administration (NASA)'s human space
6. exploration program for twenty fiscal years.
7. **SECTION 2.** NASA shall receive three billion dollars per fiscal year, beginning in
8. FY2012, to aid them in the implementation of this piece of legislation.
9. **SECTION 3.** NASA and its proprietary agencies will be responsible for the
10. implementation of this piece of legislation.
11. **SECTION 4.** This bill shall take effect on the first day of FY 2012
12. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.

1. **A Bill to Legalize Marijuana at the Federal Level**

3. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
4. **SECTION 1:** Marijuana will be removed from Schedule 1 of the Controlled Substances Act.
5. Any pill form of THC will be removed from Schedule 2 of the Controlled
6. Substances Act.
7. **SECTION 2:** The Drug Enforcement Administration (DEA) will no longer enforce the
8. prohibition of marijuana regardless of its status under state and local laws.
9. **SECTION 3:** The Internal Revenue Service (IRS) will impose an excise tax on marijuana in
10. the sixteen states that have approved marijuana for medical use. It will extend
11. the tax to any state that legalizes sale of marijuana in the future for any purpose.
12. **SECTION 4:** Tax revenue and money saved from reduced government spending on prohibition
13. enforcement will be redistributed to the general treasury.
14. **SECTION 5:** Any federal law or international treaty that conflicts with this act is now declared
15. null and void.

1. **The Ethical Treatment For Animals Act**

3. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
4. **SECTION 1:** Testing of drugs on rodents, primates, and other animals will hereby and
5. henceforth be prohibited in all fifty states and all US territories.
6. **SECTION 2:** “Animals” will include any non-human organisms within the kingdom Animalia
7. that possess nervous systems.
8. **SECTION 3:** This act will take effect immediately upon passage.
9. **SECTION 4:** Supervision of this act will be handled by the Animal Care division of the Animal
10. and Plant Health Inspection Service (APHIS) of the United States Department of
11. Agriculture (USDA), in conjunction with state and local law enforcement and
12. regulatory agencies.
13. **SECTION 5:** Any law that conflicts with this act is now declared null and void.

1. **A Bill to Commute Death Sentences for the Mentally Insane**

3. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
4. **SECTION 1:** All fifty states will be required to screen current death row inmates for mental
5. illness.
6. **SECTION 2:** The standards to determine if an inmate is mentally ill will be those set forth in
7. *Ford v. Wainwright*.
8. **SECTION 3:** Inmates determined to be mentally insane will have their sentences commuted to
9. life in prison. States must ensure that the sentence be served at a secure
10. psychiatric hospital. Or, at minimum, a corrections institution with a separate
11. facility for mental health supervision and treatment.
12. **SECTION 4:** The Department of Justice will oversee the enforcement of this act, in
13. conjunction with the Department of Health and Human Services and appropriate
14. state agencies.
15. **SECTION 5:** All mental health evaluations must be completed no later than January 1, 2014.
16. **SECTION 6:** Funding for federal enforcement of this act shall be appropriated by normal
17. means. States will not receive funding.
18. **SECTION 7:** All laws and policies in conflict are hereby deemed null and void.

1. **A Bill to Offer Undocumented Minors a Path to Citizenship**

3. BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:
4. **SECTION 1.** This bill shall be known as the Development, Relief and Education for Alien
5. Minors (DREAM) Act.
6. **SECTION 2.** The DREAM Act is defined as the legislative proposal to provide conditional
7. residency to certain illegal alien-students who graduate from US high schools that
8. immigrated illegally as minors under the guardianship of their parents.
9. **SECTION 3.** The DREAM Act is to be enforced by the US Immigration and Customs
10. Enforcement according to the following regulatory terms. Undocumented minors
11. must have proof of:
12. A. Residency in the United States before the age of 16.
13. B. Residency for more than 5 consecutive years since arrival.
14. C. For males, registration with the Selective Service at age 18.
15. D. Being between the ages of 12 and 30 at the time of enactment.
16. E. Graduation from an accredited U. S. high school, obtainment of a GED,
17. or the admission into a post-secondary higher learning institute.
18. F. A criminal record free of felony convictions.
19. **SECTION 4.** The bill is to be enacted by January 1, 2014.
20. **SECTION 5.** All laws in conflict with this legislation are hereby declared null and void.
