

A Bill to Legalize Euthanasia

BE ENACTED BY THIS CONGRESS THAT:

1 Section 1. Euthanasia will be legal in all fifty states. The certified physician administering the
2 euthanasia has the right to accept or decline the patient's request.

3 Section 2. Euthanasia is when a terminally ill patient chooses to die. However, a certified
4 physician must assist the patient.

5 Section 3. The US Department of Health and Human Services will oversee the enforcement of
6 this bill. Each state's Medical Board is responsible for certifying doctors. The
7 Medical Board certificate is mandatory for any doctor who wishes to administer
8 euthanasia to any patient. If any state's Medical Board deems a doctor to be
9 unqualified in performing euthanasia, the Medical Board may suspend or
10 terminate that doctor's certificate until said physician is deemed worthy.

11 Section 4. This bill will go into effect on January 1, 2020.

12 Section 5. All other laws that conflict with this bill shall hereby be declared null and void.

A Resolution to Limit Offshore Banking

1 WHEREAS, Offshore banking lead to a decrease in tax revenue for the government, and
2 WHEREAS, the amount of money that's put in offshore banking gets taxed less, as well as the
3 chief executive's income, and
4 WHEREAS, this results to less funding for government funded programs such as schools,
5 social security, infrastructure, and public transit, therefore be it
6 RESOLVED, By this congress to limit offshore banking by prohibiting wealthy
7 corporations from hiding their profits in offshore banks.

A Bill to Initiate School Choice

BE IT ENACTED BY THIS CONGRESS THAT:

1 Section 1. School choice will hereby be initiated throughout all schools from kindergarten to the
2 twelfth grade in the United States of America.

3 Section 2. School choice is a program where each household is given a sum of three thousand
4 five hundred dollars of non-taxable money from the federal government per child
5 attending any educational institution. The money provided will hereby be directed
6 to any institution of education that the family of the child chooses. Any money
7 that an educational institution receives will be used to pay any education-related
8 expenses.

9 Section 3. The Department of Education shall be responsible for overseeing this bill. Each
10 state's top official in the education department is responsible for requesting funds
11 from the Department of Education and allocating funds to families as is
12 appropriate.

13 Section 4. This bill shall go into effect of the 2021-2022 school year.

14 Section 5. All other laws that conflict with this bill shall hereby be declared null and void.

A Resolution to Cease Arming Teachers

1 WHEREAS: School shootings and other violent acts have recently graced media headlines, and

2 WHEREAS: Over-saturation by media sources has led many to believe the situation is rampant

3 and out of control, and

4 WHEREAS: Such manic public reactions have called for states and local legislatures to arm

5 teachers with firearms, in an attempt to curb school violence, and

6 WHEREAS: Reports from the CDC, NCJRS, and National Center for Educational Statistics all

7 find that school violence has decreased since 1993, and

8 WHEREAS: Firearms in the classroom increase both the chance for accidental discharge and the

9 potential for hostile escalation, therefore

10 BE IT RESOLVED BY THIS STUDENT CONGRESS that the carrying of firearms on any

11 public school property by any individuals who are not on-duty as a law

12 enforcement officer be banned. The state or condition of the weapon will not be

13 taken as a mitigating factor.

A Resolution to Ratify the Mine Ban Treaty

WHEREAS: Over 110 million land mines are currently deployed around the world; and

1 WHEREAS: Over 1 million people around the world have been killed and injured by anti-
2 personnel landmines; and

3 WHEREAS: Several hundred thousand children are currently disabled due to injuries sustained
4 because of landmines; and

5 WHEREAS: The United States remains one of the largest producers of landmines and retains
6 one of the largest stockpiles of landmines; and

7 WHEREAS: The United States government recognizes mines as weapons of mass destruction
8 when used by individuals or organizations; and

9 WHEREAS: The United States continues to refuse to ratify Convention on the Prohibition of the
10 Use, Stockpiling, Production and Transfer of Anti-Personnel Mines and on their
11 Destruction (Mine Ban Treaty); now, therefore, be it

12 RESOLVED that the Congress here assembled ratify the Mine Ban Treaty; and, be it

13 FURTHER RESOLVED That the definition of “weapon of mass destruction” be expanded to
14 include use of mines by governments and militaries.

A Bill to Prevent States charging Property Tax

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

- 1 Section 1: The federal government shall prevent state governments from charging property tax.
- 2 Section 2: Property tax is defined as a real estate tax that is calculated by a local government and
3 which is paid by the owner of the property.
- 4 Section 3: This bill shall be overseen by the Department of Taxation and Finance.
- 5 Section 4: This bill shall take effect at the next fiscal year, October 1, 2019.
- 6 Section 5: All laws in conflict with this legislation are hereby declared null and void.

A Bill to Ban Stop and Frisk

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 SECTION 1. All Police Departments are hereby banned from using “Stop and Frisk” or “Terry
2 Stop” procedures in order to find contraband.

3 SECTION 2. Stop and frisk is the practice by which a police officer initiates a stop of an
4 individual on the street allegedly based on reasonable suspicion of criminal
5 activity.

6 SECTION 3. The DOJ in cooperation with the FBI will oversee the enforcement of this bill.

7 SECTION 4. This bill shall be implemented immediately upon passage.

8 SECTION 5. All other laws that are in conflict shall hereby be declared null and void.

A Resolution to Lower the Voting Age

1 WHEREAS:, according the Twenty-Sixth Amendment, the current legal voting age is eighteen
2 years old, and

3 WHEREAS:, voter turnout in America is the 26th lowest out of the 32 countries in the
4 Organization for Economic Cooperation and Development (OECD), most of which are
5 developed nations, and

6 WHEREAS:, voter turnout amongst 16 and 17-year-olds in other nations is significantly higher
7 than it is amongst older young adults, and

8 WHEREAS:, 16-year-olds are already considered responsible enough to drive, work, and pay
9 taxes on their wages,

10 THEREFORE, be it resolved by the Student Congress here assembled that this Congress should
11 amend the Constitution to lower the voting age to sixteen years old.

A Bill to Legalize Safe Injection Sites

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 Section 1:

2 A. States and municipalities shall be permitted to open publicly-owned and operated
3 safe injection sites.

4 B. Federal law enforcement officers shall be banned from the premises of these sites and
5 all surveillance activities at these sites.

6 C. States and municipalities whose police departments make drug-related arrests at safe
7 injection sites shall lose all federal assistance for combatting the opioid crisis.

8 Section 2: "Safe injection sites" shall be defined as locations where drug users can inject drugs
9 while supervised by medical professionals. "Surveillance activities" shall include, but not
10 limited to, audio/video monitoring of the sites, undercover entry into the sites, or presence
11 of officers on the premises of sites.

12 Section 3: The United States Department of Justice shall oversee the implementation of this
13 legislation.

14 Section 4: This legislation shall take effect immediately upon passage.

15 Section 5: All laws in conflict with this legislation are hereby declared null and void.

Final Round: A Bill to Standardize Hospital Chargemasters

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 Section 1: The U.S. government should lower and standardize the fees of all government- funded
2 hospital chargemasters.

3 Section 2: A hospital chargemaster is a list of items billable to hospital patients and insurance
4 companies.

5 Section 3: The U.S. Department of Health and Human Services will oversee and enforce this bill.

6 Section 4: July 1, 2020 will be the start date of this bill.

7 Section 5: All other laws in conflict with this new policy shall hereby be declared null and void.

Final Round: A Bill to Enforce Mandatory Flu Vaccines

BE IT ENACTED BY THE CONGRESS HERE ASSEMBLED THAT:

1 SECTION 1: Local county government school systems will be required to check and enforce
2 the vaccination of every child.

3 SECTION 2: Government school systems shall be defined as any school that received complete
4 or partial governmental financial compensation.

5 SECTION 3: The Board of Education, along with the Health and Human Services shall oversee
6 the enforcement of this bill.

7 SECTION 4: This bill will be implemented for the 2019-2020 school year.

8 SECTION 5: All laws in conflict with this legislation are hereby declared null and void.

Final Round: A Bill to End Daylight Savings

BE IT ENACTED BY THE STUDENT CONGRESS HERE ASSEMBLED THAT:

1 SECTION 1: Daylight savings shall hereby be abolished in the United States.

2 SECTION 2: Daylight savings is defined by the Standard Time Act of 1918.

3 SECTION 3: This bill shall be overseen by the Interstate Commerce Commission.

4 SECTION 4: This bill shall take effect at January 1, 2021.

5 SECTION 5: All laws in conflict with this legislation are hereby declared null and void.
