The registration for this tournament is free and there are no minimum team requirements or "uncovered judges" fees for institutions wishing to enter. As you can see, we have built in time for you to affordably get food at the local restaurants around campus. If you anticipate bringing a significant number of uncovered teams (4+) please contact Cody well in advance of the tournament so that accommodations can be made to the judging pool.

Hotels:

Denver is home to numerous affordable hotels. For those wishing to stay close to campus contact the La Qunita Inn Cherry Creek. Hotels with light rail access are found in the Denver Tech Center and downtown Denver near the convention center. Hotels in the Tech Center will be less expensive but have limited access to nearby amenities. Please contact Darrin Hicks if you have any questions about the hotel or about crash.

Transportation: Public transportation is available from the Denver International Airport and to the competition venue via the RTD Denver light-rail. A ticket good for a full day's use usually costs about \$8-10. The airport fare is separate. A word of advice: don't risk an expensive fine! They will check for your ticket in all likelihood. Please visit <u>http://www.rtd-denver.com/</u> to check fare prices and plan your trip. The light-rail station walking distance from the competition venue is the University of Denver Station.
