A Bill to Legalize Safe Injection Sites

1	Be it enacted by this Congress that:
2	Section 1: A. States and municipalities shall be permitted to open publicly-owned and operated
3	safe injection sites.
4	B. Federal law enforcement officers shall be banned from the premises of these sites and
5	all surveillance activities at these sites.
6	C. States and municipalities whose police departments make drug-related arrests at safe
7	injection sites shall lose all federal assistance for combatting the opioid crisis.
8	Section 2: "Safe injection sites" shall be defined as locations where drug users can inject drugs
9	while supervised by medical professionals. "Surveillance activities" shall include, but not
10	limited to, audio/video monitoring of the sites, undercover entry into the sits, or presence
11	of officers on the premises of sites.
12	Section 3: The United States Department of Justice shall oversee the implementation of this
13	legislation.
14	Section 4: This legislation shall take effect immediately upon passage.

Section 5: All laws in conflict with this legislation are hereby declared null and void.

A Bill to Create a National Firearms Registry

- 2 **Section 1:** A. The National Registry of Firearms Owners (NRFO) is hereby created.
- B. All gun owners shall be required to register all firearms possessions in the NRFO.
- 4 C. All firearm transfers and sales are required to be registered in the NRFO.
- 5 **Section 2:** "Gun owners" shall be defined as individuals and organizations that own firearms.
- 6 "All firearms possessions" shall be defined as a complete list of all guns, including serial
- 7 numbers and address of the owner. "Gun transfers" shall be defined as any transaction in
- 8 which a gun is transferred to another person, regardless of whether it is sold or gifted.
- 9 Section 3: The Bureau of Alcohol, Tobacco, and Firearms shall oversee the implementation of
- this legislation.
- 11 **Section 4:** This legislation shall take effect upon passage. The NRFO must be fully operational
- 12 by January 1, 2020.
- 13 **Section 5:** All laws in conflict with this legislation are hereby declared null and void.

A Bill to Abolish Zoos

- 1 Be it enacted by this Congress that:
- 2 **Section 1:** The U.S. should abolish all zoos.
- 3 **Section 2:** A zoo is defined as an establishment that maintains a collection of wild animals,
- 4 typically in park or gardens, for study, conservation, or display to the public.
- 5 **Section 3:** This bill will be overseen by the U.S. Fish and Wildlife Service.
- 6 **Section 4:** This bill will take effect on January 1, 2025.
- 7 **Section 5:** All other laws in conflict with this new policy shall hereby be declared null and void.

A Resolution to Lower Recidivism

1	Whereas: people released from prison continue to commit crimes afterward and eventually end
2	up going back to prison, and
3	Whereas: about 67.8 percent of released prisoners were rearrested within three years of release.
4	And within five years, about 76.6 percent of criminals were rearrested. and
5	Whereas: more innocent victims will be affected, thousands of tax dollars must go to re-
6	incarceration, and prisons will need to find ways to house the inmates. Therefore be it,
7	Resolved that: this congress should look into using restorative justice programs to lower
8	recidivism rates.

A Bill to Provide More Public Restrooms

- 1 Be it enacted by this Congress that:
- 2 **Section 1**: The US should build more public restrooms.
- 3 **Section 2**: Public restroom are defined as free restrooms in public spaces.
- 4 "More" is defined as for every 55 homeless people, one more public restroom should be added.
- 5 Section 3: The enforcement of this bill should be overseen by the Department of Housing and
- 6 Urban Development.
- 7 **Section 4**: The construction of the public restrooms should be started by July 1st 2021 and
- 8 should take no more than 7 years.
- 9 **Section 5**: All other laws in conflict with this new policy shall hereby be declared null and void.

A Resolution to Protect Homeless People

- Whereas: Homelessness has served as a major problem for many years and,
- Whereas: About 554,000 people are currently homeless, 193,000 of them unsheltered and,
- Whereas: Homelessness creates a criminal safety, health, and sanitary concern, therefore be it,
- 4 **Resolved that:** This Congress should discuss providing sanctuaries for all homeless in the U.S.

1 Be it enacted by this Congress that: 2 **SECTION 1:** The publication of any blueprints or manufacturing plans used to 3D print or 3 otherwise manufacture firearms by any public or private entity shall be deemed illegal. Furthermore, the use of privately owned 3D printers for the purpose of producing 4 5 firearms shall also be deemed illegal. 6 **SECTION 2:** Firearm will be defined under current federal law: Title 18 U.S. Code § 921 as 7 "(A) any weapon (including a starter gun) which will or is designed to or may readily be 8 converted to expel a projectile by the action of an explosive; (B) the frame or receiver of 9 any such weapon; (C) any firearm muffler or firearm silencer; or (D) any destructive 10 device." 11 **SECTION 3:** Consistent under Department of Justice standards, illegal online activity relating 12 to firearms specified under this bill shall be enforced by two federal bureaus. 13 A. The Federal Bureau of Investigation shall be tasked with monitoring online activity 14 committed over either Public, Private, or Proxy networks and enforcing regulations 15 stipulated in Section 1. They will also make recommendations for prosecution based 16 upon the extent of the crime. 17 B. The Bureau of Alcohol Tobacco and Firearms shall be tasked with ensuring 18 manufacturer compliance. 19 **SECTION 4:** This bill shall take effect on November 1, 2018 20 **SECTION 5:** All laws in conflict with this legislation are hereby declared null and void

- 6 **SECTION 2:** Trade relations shall be defined as anything that results in the exchange of capital,
- 7 goods, and services across international borders or territories.
- 8 **SECTION 3:** The Department of Commerce will oversee the implementation of this item of
- 9 legislation.
- 10 **SECTION 4:** This bill will go into effect immediately.
- SECTION 5: All laws in conflict with this legislation are hereby declared null and void.
