

## EGWD Water Rates for 2022

The Elk Grove Water District completed a comprehensive water rate study in 2018, establishing rate calculations for the next five years. The study was approved by the Board of Directors at a public hearing on July 18, 2018.

In keeping with the approved action established by Resolution 06.15.21.02, the fixed charges and commodity charges will remain the same as of January 1, 2022. Specific details are included in this brochure.

## New Connections

Fees for new connections to EGWD contain two components. The base charge for a 1" meter is \$926 and larger meter installations will be charged any additional cost difference.

The second is a capacity charge, which covers the cost of "buying-in" to an existing system. New connections in EGWD's Service Area 2 do not pay the capacity charge, as those costs are part of Sacramento County's infrastructure.
