EGWD Water Rates for 2024

In keeping with the approved action established by Resolution 06.20.23.01, the fixed charges and commodity charges will increase by 4.5% effective January 1, 2024. Specific details are included in this brochure.

New Connections

Fees for new connections to EGWD contain two components. The base charge for a 1" meter is \$926 and larger meter installations will be charged any additional cost difference. The second is a capacity charge, which covers the cost of "buying-in" to an existing system. New connections in EGWD's Service Area 2 do not pay the capacity charge, as those costs are part of Sacramento County's infrastructure.
