The Elk Grove Water District completed a comprehensive water rate study in 2023 establishing rate calculations for the next five years. The study was approved by the Board of Directors at a public hearing on July 18, 2023.

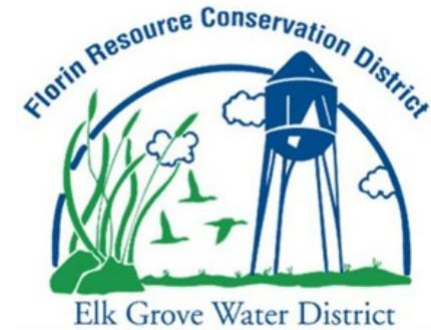

New Connections

Fees for new connections to EGWD contain two components. The base charge for a 1" meter is \$926 and larger meter installations will be charged any additional cost difference. The second is a capacity charge, which covers the cost of "buying-in" to an existing system. New connections in EGWD's Service Area 2 do not pay the capacity charge, as those costs are part of Sacramento County's infrastructure.
