# V. CEO Report

• Update – Restoration of the façade, stairs and plaza of the Civic Auditorium Michael Ross explained that no bids were submitted for the Civic Auditorium restoration. He went on to say that feedback from contractors had been that the work would be complicated, requiring various sub-contractors. As such, the contractors said that they needed more time to complete the RFP. Therefore, the RFP process will be re-opened.

Michael Ross also asked Kristin McGrath and Christine Susa to update the Executive Committee on TBID. Christine Susa said that the TBID Annual Report had been completed and is in the September Board of Directors package. A question was asked regarding the communication to the hotels about the TBID rate increase because the hotels' third-party tax filers were notified by the City of Pasadena, but the hotels were notified individually at the local level. Kristin McGrath spoke to the question and recognized that the short-term rental partners got more communication because they had not previously been included in TBID assessment at all. Some discussion ensued regarding the continued concern about the City of Pasadena's ability to enforce TBID collection from short-term rental owners.
