To whom it may concern,

I am concerned about a public safety hazard on Adobe Lane in Los Altos Hills and am writing to provide additional details for your assistance. I appreciate your efforts to investigate and resolve this matter.

At the end of January, a concrete contractor examined our driveway because the concrete was uneven. While repairing the uneven piece, they informed me that the part of the driveway closest to the road has a sinkhole that is 20 feet deep and is caved in towards the street.

It was recommended by the contractor that I contact the City since we were losing a considerable amount of soil. I went to the City to inform them of the situation. Daniel Liang and a colleague came out and examined the hole in the sewer system. He informed me that the City is only responsible for the sewer system and that nothing of concern had been found. Daniel advised me to contact the water company.

My next step was to contact Valley Water, and Ray Bramer has come out twice to inspect the issue. I have been kept informed by him, and we are currently waiting to receive a response from Valley Water about who has jurisdiction on Adobe Lane.

According to a neighbor, there is an old 6-foot pipe beneath our street, which I was only recently made aware of. I am concerned that there may be a problem with that 6-foot-pipe that is affecting our street. I would like to have the street extensively checked for this potentially massive hazard and keep our residents, street, and the public safe. Your assistance is greatly appreciated.





We share your deep frustration and disappointment regarding the escalating issues, including relentless fires, the presence of firearms, and hazardous waste, which pose an intolerable threat to our community, especially our school children.

The safety of our children and residents is our top priority. I completely understand your sentiment, and I want to assure you that we take this matter very seriously.

We are committed to working closely with the appropriate departments to address this matter. Your concerns

have been documented, and the attached pictures and video link provide valuable insights into the gravity of the situation.

Dear Wendy Li,

Thank you for reaching out to Valley Water and sharing your continued frustrations related to the encampments of unsheltered people located near your home along Los Gatos Creek. We are sympathetic to your concerns and are dismayed to hear of your recent experience involving harassment and racial profiling.

Valley Water is committed to using the power we have as an environmental stewardship agency to protect our waterways in collaboration with the cities and the County as they fulfill their public safety and social service roles. However, as with all public agencies, Valley Water must adhere to applicable case law, which has

significantly affected how we can respond to encampments of unsheltered persons. There is a requirement that shelter be offered before unsheltered people may be relocated from public lands; however, given the unprecedented need for transitional and long-term housing in Santa Clara County, there is currently only shelter capacity for approximately one quarter of the unsheltered population. For this reason, there is often little that Valley Water can do to relocate encampments until there are sufficient housing alternatives.

As you mentioned in your message, the Valley Water-sponsored State Assembly bill, AB 1469 (Kalra) *Valley Water Assisting Unsheltered People*, took effect on January 1st of this year. Although AB 1469 did not provide Valley Water with any new funding, this legislation amends the District Act to authorize Valley Water to assist unsheltered people living along streams, in riparian corridors, or otherwise in the district's jurisdiction, in consultation with a city or the County of Santa Clara, to provide solutions or improve outcomes for the unsheltered individuals. AB 1469 is intended help Valley Water comply with the federal case law that requires a legitimate offer of shelter before relocating an unsheltered person from public land. In February, Valley Water staff provided a presentation to the Environmental Creek Cleanup Committee and received feedback on what Valley Water's efforts under AB 1469 should look like. The next step is for our full Board to work through the annual budget-setting process to determine an amount of funding to devote to these efforts. Once a funding level is established, staff will bring back specific proposals to develop housing for unsheltered individuals residing on Valley Water property, which may include partnerships with developers of tiny homes and other interim and permanent housing communities.

We appreciate your comments and understand your concerns. 
Hi Valley Water board members + Jennifer,

It was great to hear from the last meeting that the members of the encampment committee recognize how frustrating it's been that there's been no change in the camping situation on many of the creeks including Los Gatos creek for over a year even though initial plans were started for a relocation set up for it.

In the last encampment meeting (set around August), Jim Bealle mentioned that he wanted to set up a timeline and action items for how to use the newly allocated funds for assisting the homeless that opened up in January. In the last meeting, he again expressed his desire for action items and to see results. Rebecca Eisenberg also expressed her desire to see action being taken and suggested working with a tiny home non-profit and providing funding for tiny homes to be built for relocation. I wanted to check in with the council and ask if action plans were written up and a timeline established six months ago. I also wanted to check in with you guys and see if action items were planned from the last meeting and a time line established for the development of tiny homes.

I am also writing this as I'm waiting on the police to arrive so I can file a police report. A homeless man just tried to hit me with his bike, screamed profanities at me and called me a fucking Korean (I am not ethinically Korean and am a US citizen). I just wanted to walk my dog quietly on the creek before the sun went down and it was still safe to do so. I was not expecting to be harassed and racially profiled and am sick and tired of these experiences becoming a common occurrence.

Like Ms. Eisenberg emphasized, people are dying outside from exposure and the rain, the creek is being severely eroded (which will then contribute to future risk of flooding) and the residents around the creeks are suffering. Please treat this like the urgent matter that it is.

Thank you for bringing your concerns regarding the encampment on Willow Street and Lelong Street to our attention. Mayor Mahan understands the gravity of the situation and has alerted the San Jose Police Department's Division Captains about the rising concerns in the area. However, it's essential to follow the proper procedure when reporting criminal activity to ensure effective action can be taken.

The District Attorney's Office has advised us that in order to build a strong case and take legal recourse, such as arrests or removal of hazards, an official report must be made to the Police Department. By doing so, we can track crime statistics in your specific area, which will help us advocate for increased police presence and

# Hello,

I am writing to you today to express my concerns regarding the ongoing issues we are facing in our community, particularly on Lelong. While I acknowledge the strides that have been made in addressing concerns on county or city sections, I am increasingly dismayed by the lack of effort being put forth to resolve the situation comprehensively by the Water Company.

Our primary concern is the safety and well-being of our families. It deeply troubles me to report incidents of individuals walking around with knives at night, unlawfully rummaging through mailboxes, vehicles, and even our trash. Just recently, as my husband and boys were walking to Walgreens, I witnessed a man wielding a knife following closely behind them. This alarming incident underscores the urgency of the situation.

Furthermore, the deteriorating safety conditions have greatly impacted our daily lives. My sons, who have friends on the other side of the freeway, are now unable to walk to each other's homes due to safety concerns. Additionally, many families in our neighborhood used to walk to Willow Glen Elementary, but students living near Lelong are now deprived of this option due to safety risks. Our children have seen people take off their clothes and use the sidewalk as their facility to defecate as we drive home. I had to move their rooms as their bedroom faced the street, and we reported people showering at the El Paseo Dental Care before they were fully open. Our own water bill has increased, and we see our hose has been displaced.

In addition to safety concerns, the situation on Lelong within the Water Company jurisdiction has exacerbated traffic issues in our community. Illegal dumping of items only worsens the situation, creating a hazardous environment for residents and commuters alike.

I implore you to recognize the severity of these issues and take decisive action to address them promptly. It is crucial to understand that delaying action will only allow the problem to escalate, resulting in greater expenses and risks for our community. I firmly believe that the city and the Water Company must work together to find solutions and ensure the safety and well-being of all.

I urge you to reconsider your approach and actively engage to develop a shared responsibility and call to action plan. We, the residents, are willing to support the city in its efforts, but we need your leadership and the collaboration of the Water Company to make meaningful progress.

I have attended numerous town hall meetings where the city has emphasized that the cost of addressing these issues will fall on the shoulders of the Water Company and that the Water Company needs to reach out to the city for support. I urge you to heed this call and take proactive steps to address the pressing concerns on Lelong.

Lastly, calls to the police are not prioritized within our community. Therefore, if something happens to anyone in my family, the Water Company and the city will be liable as I have expressed my concern for our safety through this communication.

Thank you for your attention to this matter. I look forward to seeing concrete actions and initiatives aimed at improving the safety and quality of life in our community.

Have you considered removing the fence and creating a paved walkway / greenbelt there? Making this an accessible open space that people actively made use of for recreation, similar to the Los Alamitos creek trail, may be a relatively low-cost solution.

Regarding the sheltering of these individuals, I share everyone's concern for their well-being. But I think we do them the greatest disservice by encouraging / allowing them to camp wherever they can find. It increases environmental, health, and public safety risks, especially when they camp on parts of the watershed and it offers them no support. We'd be far better off grabbing several acres of public land to create an unofficially sanctioned tent-village with minimal VTA, sanitation, social, and safety services than to have them camp ad-hoc in this way.

Thank you for sharing your concerns related to the encampments of unsheltered people located on Guadalupe Creek along Coleman Road between Meridian Avenue and Almaden Expressway. Valley Water is committed to using the power we have as an environmental stewardship agency to protect our waterways in collaboration with the cities and the County as they fulfill their public safety and social service roles. However, as with all public agencies, Valley Water must adhere to applicable case law, which has significantly affected how we can respond to encampments of unsheltered persons.

As you may be aware, a 2019 court ruling by the 9th Circuit Federal Court of Appeals in the case of Martin v. Boise has limited the ability of California public agencies to relocate unsheltered individuals who are camping on public lands. This ruling holds that governments in the court's jurisdiction (which includes California) cannot enforce ordinances that ban public camping or criminalize sleeping outdoors on public property if there is no real option for sleeping indoors. Shelter is required to be offered before unsheltered people may be relocated from public lands; however, given the unprecedented need for transitional and long-term housing in Santa Clara County, there is currently only shelter capacity for approximately one quarter of the unsheltered population. For this reason, there is often little that Valley Water can do to relocate encampments until there are sufficient housing alternatives. Although encampment relocations are curtailed at this time, our crews continue to perform large scale trash cleanups throughout jurisdictional areas countywide to prevent encampment-generated trash and debris from polluting the waterways.

In terms of strategic solutions, a Valley Water-sponsored State Assembly bill, *AB 1469 (Kalra) Valley Water Assisting Unsheltered People*, took effect on January 1, 2024. AB 1469 amends the District Act to authorize Valley Water to assist unsheltered people living along streams, in riparian corridors, or otherwise in the district's jurisdiction, in consultation with a city or the County of Santa Clara, to provide solutions or improve outcomes for the unsheltered individuals. Specifically, the bill allows Valley Water more flexibility to use district land and a part of an existing ad valorem property tax for lasting encampment solutions. The intent is to work with local cities or the County to construct low-barrier navigation centers, supportive housing, transitional housing, affordable housing, or other facilities to assist unsheltered people. These facilities would be operated by a city, the County, or a non-profit with the appropriate expertise to provide shelter and services that can improve outcomes for unsheltered people. AB 1469 will help Valley Water comply with the federal case law that requires a legitimate offer of shelter before relocating an unsheltered person from public land.

Regarding the breached chain-link fence that you reported, Valley Water is aware of this ongoing issue. Unfortunately, the fencing in this area suffers new breaches almost immediately after Valley Water repairs the holes. Nevertheless, we will send staff out as soon as possible to conduct an inspection and make repairs as necessary. And we will consider what can be done to achieve a more long-term solution. As always, if you witness illegal activity or a threat to public health and safety, please contact the police; and if you observe smoke or fire, please contact the fire department. Concerns relating to unwanted or illegal behaviors and fires are best handled by City resources. Since Valley Water is not a law enforcement agency, we must work in concert with cities and the County to address these types of activities.

**Recommendation to Valley Water Board** 

In reviewing the information available to the public, such as the <u>2040 Water Supply Master Plan</u>, an alternative project set evaluation comparison to Pacheco Reservoir Expansion has <u>not</u> been done by Valley Water and/or published.

The logical Pacheco expansion infrastructure project alternatives are:

- Vaqueros Reservoir expansion with VW being a partner. However, reservoir expansions continue the high dependency on importing the county's water needs from the Delta (≈45%) and Hetch Hetchy (≈16%). Delta sourced water is highly susceptible to droughts; thus, very unreliable.
- For less than VW's 65% planned investment share in Pacheco's expansion, with little investment uncertainty, Valley Water could **expand waste water recovery** beyond the planned (12%) to ≈85%, like Orange County has **and implement desalinization**, like San Diego's Carlsbad \$1B desalinization plant (water output 122,000 AF/yr. at \$2,000/AF), employing osmosis processes. Reverse osmosis plant processing of brackish water near Pittsburg<sup>o</sup> from SF Estuary would be established generating potable water in partnership with other Water Districts. The project's cost would include an environmentally benign electric energy generation plant located elsewhere on the power grid to offset osmosis processes' high electrical energy operating requirement. Together these two osmosis-based projects and solar electrical energy plant, appropriately scaled, could statistically guarantee water supply reliability for the most demanding drought scenarios yet remain more affordable than the current planned Pacheco expansion.

Δ Like San Francisco Utilities Commission has, a more demanding 7-year drought scenario than the current 1982-92 5-year period should be employed on WEAP for assessing drought water supply reliability.

The alternative project assessment to Pacheco expansion should be performed in the next 3 months. This could easily be accomplished by a small Valley Water analytical team. The team could obtain all the needed data from operators of Orange County's waste water recycling operation, San Diego's Carlsbad Desalinization Plant and other respected resources. The results should be published for public review and critique. Immediately after the public review, a "Go/No Go" decision by VW's Board of Directors be made in public regarding continued pursuit of the Pacheco reservoir Expansion project versus the identified alternatives with rational.

The impact on end consumer retail water rates must be projected and estimated from the ultimate project infrastructure mix pursued by VW in constant economics. Continued non-disclosure of this significant retail water rate impact is deceptive.

Thank you for reaching out to Valley Water and sharing your continued frustrations related to the encampments of unsheltered people located near your home along Los Gatos Creek. We are sympathetic to your concerns and are dismayed to hear of your recent experience involving harassment and racial profiling.

Valley Water is committed to using the power we have as an environmental stewardship agency to protect our waterways in collaboration with the cities and the County as they fulfill their public safety and social service roles. However, as with all public agencies, Valley Water must adhere to applicable case law, which has significantly affected how we can respond to encampments of unsheltered persons. There is a requirement that shelter be offered before unsheltered people may be relocated from public lands; however, given the unprecedented need for transitional and long-term housing in Santa Clara County, there is currently only shelter capacity for approximately one quarter of the unsheltered population. For this reason, there is often little that Valley Water can do to relocate encampments until there are sufficient housing alternatives.

As you mentioned in your message, the Valley Water-sponsored State Assembly bill, AB 1469 (Kalra) *Valley Water Assisting Unsheltered People*, took effect on January 1st of this year. Although AB 1469 did not provide Valley Water with any new funding, this legislation amends the District Act to authorize Valley Water to assist unsheltered people living along streams, in riparian corridors, or otherwise in the district's jurisdiction, in consultation with a city or the County of Santa Clara, to provide solutions or improve outcomes for the unsheltered individuals. AB 1469 is intended help Valley Water comply with the federal case law that requires a legitimate offer of shelter before relocating an unsheltered person from public land. In February, Valley Water staff provided a presentation to the Environmental Creek Cleanup Committee and received feedback on what Valley Water's efforts under AB 1469 should look like. The next step is for our full Board to work through the annual budget-setting process to determine an amount of funding to devote to these efforts. Once a funding level is established, staff will bring back specific proposals to develop housing for unsheltered individuals residing on Valley Water property, which may include partnerships with developers of tiny homes and other interim and permanent housing communities.


Hi Valley Water board members + Jennifer,

It was great to hear from the last meeting that the members of the encampment committee recognize how frustrating it's been that there's been no change in the camping situation on many of the creeks including Los Gatos creek for over a year even though initial plans were started for a relocation set up for it.

In the last encampment meeting (set around August), Jim Bealle mentioned that he wanted to set up a timeline and action items for how to use the newly allocated funds for assisting the homeless that opened up in January. In the last meeting, he again expressed his desire for action items and to see results. Rebecca Eisenberg also expressed her desire to see action being taken and suggested working with a tiny home non-profit and providing funding for tiny homes to be built for relocation. I wanted to check in with the council and ask if action plans were written up and a timeline established six months ago. I also wanted to check in with you guys and see if action items were planned from the last meeting and a time line established for the development of tiny homes.

I am also writing this as I'm waiting on the police to arrive so I can file a police report. A homeless man just tried to hit me with his bike, screamed profanities at me and called me a fucking Korean (I am not ethinically Korean and am a US citizen). I just wanted to walk my dog quietly on the creek before the sun went down and it was still safe to do so. I was not expecting to be harassed and racially profiled and am sick and tired of these experiences becoming a common occurrence.

Like Ms. Eisenberg emphasized, people are dying outside from exposure and the rain, the creek is being severely eroded (which will then contribute to future risk of flooding) and the residents around the creeks are suffering. Please treat this like the urgent matter that it is.

Dear Anthony Quijada,

Thank you for reaching out to Valley Water regarding the encampments of unsheltered people located along the Los Gatos Creek Trail near your home. Regarding trespassing enforcement, while Valley Water-owned land is considered public property, this does not mean that members of the public are authorized to access all Valley Water lands, as they would expect in a public park or on a trail. Valley Water lands or facilities with restricted access have been marked with the "No Trespassing" signs that you observed. These restrictions are important to make sure the public has access to safe recreation opportunities. However, enforcement of some rules and ordinances on the unsheltered community is not currently supported by the courts, as case law says that public agencies can't penalize unsheltered people for public camping if the local municipality cannot provide adequate offers of housing.

Specifically, the applicable 2019 court ruling by the 9th Circuit Federal Court of Appeals in the case of Martin v. Boise holds that governments in the court's jurisdiction (which includes California) cannot enforce ordinances that ban public camping or criminalize sleeping outdoors on public property if there is no real option for sleeping indoors. This ruling has limited the ability of California public agencies to relocate unsheltered individuals who are camping on public lands. Shelter is required to be offered before unsheltered people may be relocated from public lands; however, given the unprecedented need for transitional and long-term housing in Santa Clara County, there is currently only shelter capacity for approximately one quarter of the unsheltered population. For this reason, there is often little that Valley Water can do to relocate encampments until there are sufficient housing alternatives.

Although encampment relocations are curtailed at this time, our crews continue to perform large scale trash cleanups throughout jurisdictional areas countywide to prevent encampment-generated trash and debris from polluting the waterways. Recently, Valley Water's Board of Directors approved new staffing resources to support greater service and coordination toward cleaning up trash, debris, and hazardous pollutants produced by encampments along waterways in Santa Clara County. This increased level of service means that Valley Water cleanup crews will be able to visit impacted areas more often. Our encampment cleanup crew visited the reach of Los Gatos Creek from Bascom Avenue to Meridian Avenue on February 26th through 28th and removed 26.4 tons of encampment-generated trash and debris.

Thank you for your response. I saw there is a zoom meeting this Thursday. I will possibly be attending but I wanted to bring this to your attention first.

I am resident at the River Walk Apartments located at 1510 S. Bascom Ave. directly next to the Los Gatos Creek Trail. You may be aware of the homeless encampment on the embankment near the corner of S. Bascom Ave and Southwest Expy. This embankment is property of the San Jose Valley Water District. I have attached videos to this email showing how much of a problem this area has become. There is a sign posted that says "No Trespassing". However, it seems this encampment is being allowed to form. Last week, I spoke to a group of officers that I saw walking this area. They informed me they were looking for anyone with warrants, but didn't have authorization to trespass anyone. Now that I see there is a no trespassing sign that makes no sense to me.

I am reaching out as a concerned resident looking for how to remove this encampment from the area. I could easily start a petition if you find that would be helpful to this cause. I am sympathetic towards the homeless population but also understand that Santa Clara County offers a ton of programs and assistance to those in need. I do see cleanup crews every couple of months to clean this area. However, I believe it's time for significant changes. One of the videos shows the fence has been opened to make an entrance. That fence appears to be property of the apartment complex next to it. There should be a joint effort made to secure this entrance point with new heavy-duty fencing.

Valley Water is very active on the lands we manage in this area, and we are aware of the fire incidents that you cited in your message. As part of Valley Water's encampment management efforts, our field staff conduct encampment risk assessments that consider factors such as recent fire activity and the presence of open flames adjacent to flammable structures. These assessments may lead to the removal of certain encampments on Valley Water property if it can be proven that they are responsible for causing wildfire or other fire dangers. Regarding your specific mention of the fires of February 23<sup>rd</sup> and 26<sup>th</sup>, these occurred on land underneath the Highway 85 overpass that is owned and managed by Caltrans. Valley Water staff responded to the scene and promptly reported these events to Caltrans.

Valley Water is committed to using the power we have as an environmental stewardship agency to protect our waterways in collaboration with the cities and the County as they fulfill their public safety and social service roles. Enclosed are two pictures of our most recent homeless fire that occurred yesterday, 2/26/24 under HY 85 at the perc pond area behind the Senior Facility formerly known at the Atrium. The second pic captures the amount of resources deployed to combat this fire.

On Friday, 2/23/24, there was a similar fire in this same area.

Regularly, residents are experiencing pungent smell of toxic materials being burned by the homeless.

This is a TOTAL PUBLIC SAFETY HAZARD. We have recently had residents bordering that area list their home for sale and my understanding is they had to report the homeless situation surrounding them and sold the home at a LOSS.

I have been a 40 year resident in my home and I have also noticed a substantial increase in my Homeowner's Insurance Premiums.

I wanted to make sure you saw these pictures and have read what I have submitted to you. I know in times past, there were similar fires that some/all of you were not aware had occurred.

Homes have already been evacuated in the past on Tonino due to the fires lapping their backyard fences from the homeless encampments. What is going to happen next? What is it going to take to ensure our safety?

My family no longer walks the trails as it is just too dangerous and we fear for our safety.

To the Board of Valley Water,

I have lived 28 years on Fell Court. My husband and I raised 4 children and have loved this location. We often road bikes or walked to Almaden Lake and loved that we could do it on the path adjacent to the percolation ponds and stream totally avoiding any streets with cars. The last 7 years I was doing it with my grandkids, but not since the homeless community has multiplied. It is just not safe.

Today under the freeways on this island where about 25 tents are set up there was a large fire. It could be seen for miles. The firetrucks and police were out there as the fireman where trying to put it out Last week there was another fire that was on the land to the right the percolation ponds where there is a huge encampment. The smell was so toxic!! It smelled like they were burning tires. The neighbors all started texting each other. There are fires large and small that we all have to deal with on a regular basis. My niece lives at the back of Dawnview Ct. and is always affected by these fires. So sad because her husband and her bought this over a million dollar home right before the homeless took over the land behind their house.

I'm sure you will know this name, Brigitte Rince, who constantly contacted you as she daily dealt with homeless community incidents since she lived on the end of Chynoweth on the right side of the street. She was traumatized by having to deal with a women screaming being raped, gun shots during the night, intruders from the homeless community in her yard yelling at her, numerous fires, and much more. Her husband Mark and her were long time residents and well liked and respected in our neighborhood. Well, they couldn't take it any more and moved out and

now their house is up for sale. It's going on 3 weeks, but no sale. Beautifully remodeled kitchen and bathroom, pool, and large lot, but who would want to buy that house when they see all the tents right by her yard and on the other side of the lake. Another family had to disclose the homeless encampment when they put there house for sale and it really affects property values.

In the last 5 year+ all my neighbors have bought security cameras or burglar alarms due to cars being broken into. Quite often we are calling each other to ask if they can look at the view from their camera's angle due to some type of intrusion or attempted break in. This is since the encampment.

We have had one man with a sword try to steal toys from a little boy on our block. We had to call the police because he disappeared and we knew he didn't leave the court. He ended hiding behind a garbage can and scared my female neighbor when he jumped out at her with his sword. He is well know as he had bothered others on other streets. He definitely has mental illness, like a lot of the homeless unfortunately suffer from.

I know that you are planning to put tiny homes by the bass shopping center, and I was glad to hear this, but it will definitely not be able to house all these people in tents. Plus, I understand some prefer living in the tents. Some may move, but what is going to keep more people moving into the spaces that become vacant? Thank you for your email and concerns regarding the carpets along the South Bay Salt Ponds. Staff will respond separately to your questions submitted to our Public Records Request department.

Regarding public access and recreational use at the South Bay Salt Ponds, Valley Water is currently working in partnership with the <u>South Bay Salt Pond Restoration Project</u> (SBSPRP) on the Calabazas/San Tomas Aquino Creek-Marsh Connection Project which aims to restore creek-marsh connections and tidal flows to establish 1,800 acres of tidal marsh in the A8 Ponds and Pond A4. This project has been having public meetings, including meetings focused on public access.

I received notice that this case was closed so I made a site visit and found that while the bulk of carpets are removed there is substantial work to complete remediation.

Firstly, there are many carpet remnants still in place as well as many plastic spikes inserted into the soil. The carpet remnants are a bigger concern but they should all be removed at some point.

Secondly, there is now uncovered soil with no vegetation which is now subject to erosion by rain, wind and waves. There must either be some type of mulch fabric, or vegetation or a combination in order not to have excessive erosion enter the bay waters.

Lastly, I would like to ask more questions about how this carpet installation came about and the process steps which allowed the installation. It should be obvious to all parties that this installation is highly inappropriate and in my view is gross pollution and should not have been allowed.

Sunnyvale representative (Rohan A. WIKRAMANAYAKE, P.E. Division Manager, Water Pollution Control Plant) indicates that a group of kiteboarders did this installation and it is Valley Water jurisdiction. I feel that kitesurfing is or should not be permitted in this area as it would be quite disruptive to wildlife. <a href="https://scvas.org/salt-ponds-of-santa-clara-county">https://scvas.org/salt-ponds-of-santa-clara-county</a>. Kitesurfing is only appropriate in open areas of the bay and not in sensitive wildlife habitat.

If you would like me to join you in a site visit with representatives I can show you the remaining issues.

Dear Zachariah Zachariah,

Thank you for sharing your experiences related to the encampments of unsheltered people located near the percolation ponds in your neighborhood. Valley Water is committed to using the power we have as an environmental stewardship agency to protect our waterways in collaboration with the cities and the County as they fulfill their public safety and social service roles. However, as with all public agencies, Valley Water must adhere to applicable case law, which has significantly affected how we can respond to encampments of unsheltered persons.

As you may be aware, a 2019 court ruling by the 9th Circuit Federal Court of Appeals in the case of Martin v. Boise has limited the ability of California public agencies to relocate unsheltered individuals who are camping on public lands. This ruling holds that governments in the court's jurisdiction (which includes California) cannot enforce ordinances that ban public camping or criminalize sleeping outdoors on public property if there is no real option for sleeping indoors. Shelter is required to be offered before unsheltered people may be relocated from public lands; however, given the unprecedented need for transitional and long-term housing in Santa Clara County, there is currently only shelter capacity for approximately one quarter of the unsheltered population. For this reason, there is often little that Valley Water can do to relocate encampments until there are sufficient housing alternatives.

We want to assure you that Valley Water is actively working in concert with our agency partners and the community to address encampments of unsheltered people. We are currently working with the City of San José to resolve the encampments located on our property in your area. Valley Water and the City are negotiating the development of nearly 100 Emergency Interim Housing (EIH) units on Valley Water's undeveloped 2.52-acre lot along Cherry Avenue between the Guadalupe River and the Almaden Ranch shopping center. The project has been approved by both bodies, the site has been surveyed, and efforts are ongoing to develop a collaborative agreement to move forward toward construction. Importantly, once this EIH site has been established, and after safe relocation of unsheltered individuals living in this reach of the Guadalupe River into the EIH community has taken place, a Water Resources Protection Zone (WRPZ) will be established along Guadalupe River from Branham Lane in the north to Blossom Hill Road in the south. The WRPZ will be kept clear of camping, fires, damage to vegetation and wildlife, and pollution to the water, and joint City and Valley Water efforts will aim to protect this reach by ensuring that it remains clear of encampments in the future.

In terms of strategic solutions, a Valley Water-sponsored State Assembly bill, AB 1469 (Kalra) *Valley Water Assisting Unsheltered People*, took effect on January 1, 2024. AB 1469 amends the District Act to authorize Valley Water to assist unsheltered people living along streams, in riparian corridors, or otherwise in the district's jurisdiction, in consultation with a city or the County of Santa Clara, to provide solutions or improve outcomes for the unsheltered individuals. Specifically, the bill will allow Valley Water more flexibility to use district land and a part of an existing ad valorem property tax for lasting encampment solutions. The intent is to

work with local cities or the County to construct low-barrier navigation centers, supportive housing, transitional housing, affordable housing, or other facilities to assist unsheltered people. These facilities would be operated by a city, the County, or a non-profit with the appropriate expertise to provide shelter and services that can improve outcomes for unsheltered people. AB 1469 will help Valley Water comply with the federal case law that requires a legitimate offer of shelter before relocating an unsheltered person from public land.

Finally, Valley Water is aware of the recent fires that occurred underneath the Highway 85 overpass on land owned and managed by Caltrans. Valley Water staff responded to the scene and promptly reported these events to Caltrans. Concerns relating to fires and unwanted or illegal behaviors are best handled by local fire and police departments, which are City of San José resources. Please continue to contact the police or fire department if you observe illegal activity, a threat to public health and safety, or smoke/fire. Since Valley Water is not a law enforcement agency, we must work in concert with cities and the County to address these types of activities.

As you may be aware, a 2019 court ruling by the 9th Circuit Federal Court of Appeals in the case of Martin v. Boise has limited the ability of California public agencies to relocate unsheltered individuals who are camping on public lands. This ruling holds that governments in the court's jurisdiction (which includes California) cannot enforce ordinances that ban public camping or criminalize sleeping outdoors on public property if there is no real option for sleeping indoors. Shelter is required to be offered before unsheltered people may be relocated from public lands; however, given the unprecedented need for transitional and long-term housing in Santa Clara County, there is currently only shelter capacity for approximately one quarter of the unsheltered population. For this reason, there is often little that Valley Water can do to relocate encampments until there are sufficient housing alternatives. Although encampment relocations are curtailed at this time, our crews continue to perform large scale trash cleanups throughout jurisdictional areas countywide to prevent encampment-generated trash and debris from polluting the waterways.

In terms of strategic solutions, a Valley Water-sponsored State Assembly bill, *AB 1469 (Kalra) Valley Water Assisting Unsheltered People*, took effect on January 1, 2024. AB 1469 amends the District Act to authorize Valley Water to assist unsheltered people living along streams, in riparian corridors, or otherwise in the district's jurisdiction, in consultation with a city or the County of Santa Clara, to provide solutions or improve outcomes for the unsheltered individuals. Specifically, the bill allows Valley Water more flexibility to use district land and a part of an existing ad valorem property tax for lasting encampment solutions. The intent is to work with local cities or the County to construct low-barrier navigation centers, supportive housing, transitional housing, affordable housing, or other facilities to assist unsheltered people. Regarding the breached chain-link fence that you reported, Valley Water is aware of this ongoing issue. Unfortunately, the fencing in this area suffers new breaches almost immediately after Valley Water repairs the holes. Nevertheless, we will send staff out as soon as possible to conduct an inspection and make repairs as necessary. And we will consider what can be done to achieve a more long-term solution. As always, if you witness illegal activity or a threat to public health and safety, please contact the police; and if you observe smoke or fire, please contact the fire department. Concerns relating to unwanted or illegal behaviors and fires are best handled by City resources. Since Valley Water is not a law enforcement agency, we must work in concert with cities and the County to address these types of activities.
