1. Anderson FERC Application

The Santa Clara Valley Water District (Valley Water) proposes to decommission the hydroelectric facility located at Anderson Dam in Morgan Hill, California. The decommissioning of the hydroelectric facility will occur as a part of the Anderson Dam reconstruction to meet federal and state dam safety requirements, known as the Anderson Dam Seismic Retrofit Project (ADSRP).

In 1984, the Federal Energy Regulatory Commission (FERC) issued Valley Water a small hydroelectric facility "exemption" from licensing (a form of federal permit). Valley Water is filing for the surrender of this federal exemption and as part of this surrender process, the Draft Petition for Surrender of Exemption (Draft Petition) was submitted on September 28, 2023 and is available for a 90-day review period. The Draft Petition is a document that explains Valley Water's plan and

reasoning for surrendering the existing exemption for operation of the hydroelectric facility. The action will include decommissioning of the hydroelectric facility, retrofitting Anderson Dam, and incorporating environmentally beneficial components into ADSRP. The comment review period for the Draft Petition will conclude on December 28, 2023. Email and written comments will be accepted until 5:00p.m. on December 28, 2023. Please email comments to Anderson_FERC@valleywater.org or send written comments to the following address:

As a reminder, Valley Water prepared the draft Environmental Impact Report in compliance with the California Environmental Quality Act, which is also included as a link in Appendix A to the Draft Petition. Valley Water made the draft Environmental Impact Report available for public review on September 1, 2023, and public comments on that document are due on November 1, 2023.

The Draft Petition represents over 5 years of early consultation efforts between Valley Water and all of the natural resource/permitting agencies, which included over 150 meetings, thousands of hours of staff time, and the development of significant conservation measures that will improve habitat conditions in Coyote Creek long after the seismic retrofit is completed. Valley Water anticipates submitting our application for a Lake and Streambed Alteration Agreement for ADSRP in the summer 2024 and we will continue our coordination efforts to develop the permit application and support the permit review process.

Advancing this project as expeditiously as possible continues to be Valley Water's top priority, not only for water supply, public safety, and incidental flood risk reduction benefits, but also for restoring habitat in Coyote Creek and Anderson Lake. Having Anderson Reservoir restored and operable allows Valley Water to implement a suite of conservation measures included in ADSRP. The conservation measures will provide an improved flow regime, directly enhance nearly two miles of steelhead habitat and improve ecosystem function, water quality, and fish passage.

2. Coastal Cleanup Day - Saturday, September 23, 2023

In support of the 39th annual Coastal Cleanup Day (CCD), Valley Water, in collaboration with the Creek Connections Action Group (CCAG) and the California Coastal Commission, coordinated another successful cleanup event in Santa Clara County on Saturday, September 23, 2023.

The CCAG is a consortium of public agencies and non-profit organizations that share a goal of protecting Santa Clara County's waterways. These agencies include the Santa Clara Valley Water District (Chair), Santa Clara County Parks and Recreation, the City of San José (Parks Recreation and Neighborhood Services, Environmental Services Department), City of Santa Clara, City of Palo Alto, City of Sunnyvale, City of Milpitas, City of Cupertino, and West Valley Clean Water Program (Campbell, Monte Sereno, Saratoga and the Town of Los Gatos).

This year, there were 53 cleanup sites throughout the county. A total of 1,207 volunteers cleaned 61 miles of creek, shoreline, and natural areas, removing approximately 26,071 pounds of trash and recyclables.

One of this year's 53 sites was located at the Guadalupe River behind Valley Water Headquarters and hosted by the Valley Water Youth Commission and attended by Director Beall. A San Jose State University reporter came to the Youth Commission cleanup site to discuss the importance of creek cleanups and volunteer support. Assemblymember Gail Pellerin (D-28) also hosted a cleanup site in Morgan Hill at the Madrone Channel.

Some of the most interesting items volunteers picked up include: a mini fridge, counterfeit \$100 bill, suitcase, "not a through street" sign, bike frames, ATM machine, spaghetti, cable box, smiley face ring, iMac, a statue of liberty figurine, snorkel, credit cards, driver's license, water heater, ship captain statue, an undeveloped roll of film, fishing poles, digital camera, a high school yearbook, computer monitor, mop, full bottle of cleaning agent, fake tree, playing cards, and a keyboard.

Valley Water will continue to leverage the momentum from the volunteers to encourage them to sign up for the Adopt-A-Creek Program and other Valley Water volunteer efforts, including National River Cleanup Day in May of next year.

3. Safe, Clean Water Refill Station Grant Closeout: Union School District's Valley Water Refill Station Project – Guadalupe Elementary School

In Fiscal Year 2023, Valley Water awarded Union School District a \$5,000 Safe, Clean Water Program F9 Valley Water Refill Station Grant for their Valley Water Refill Station Project (Project) at Guadalupe Elementary School. Union School District completed the Project on August 24, 2023 and submitted the final invoice items on August 29, 2023, allowing for grant closeout.

Union School District is a public school district that serves over 5,500 students across eight schools in San Jose, CA. The grant funds were used to purchase and install a new water bottle refill station at Guadalupe Elementary School. The Project provides access to safe, clean drinking water to more than 500 school-age students (pre-K to 5th grade). The station features a counter that tracks how many plastic water bottles are saved each time the station is used.

Key Outcomes:

- Installed one new water bottle refill station at Guadalupe Elementary School to serve more than 500 students.
- Promotes the use of reusable water bottles and reduces the amount of plastic water bottle waste generated by students, staff, and visitors.
- Saved over 300 plastic water bottles within one week of installation.

4. Valley Water Wins WaterSense Partner of the Year Awards from U.S. EPA

The U.S. Environmental Protection Agency (EPA) named Valley Water a WaterSense Partner of the Year. The WaterSense Partner of the Year Award is a competitive national award recognizing agencies that have gone above and beyond to promote an ethic of water efficiency to conserve

water resources for future generations. Valley Water will receive its Partner of the Year Award at the WaterSmart Innovations Conference luncheon in Las Vegas, Nevada on October 5, 2023.

As a first-time applicant, Valley Water was recognized for its outstanding water conservation programs, water-saving collaborations, and outreach efforts. The application highlighted Valley Water's conservation programs including the Online Shopping Cart (eCart), Landscape Rebate Program (LRP), and Fixture Replacement Program (FixRP). The application also highlighted Valley Water's outreach efforts including a multilingual water conservation campaign, "Is Your Yard Drought Ready? Our Rebates Can Help Make the Change" and the Speakers Bureau Program which provided drought information to community groups, service clubs, neighborhood associations, homeowners' associations, libraries, senior centers, and city councils across Santa Clara County.

On September 28, 2023, Valley Water provided Director Eisenberg links to several Egnyte folders that contain the information requested, including all correspondence with U.S. EPA regarding Water Infrastructure Finance and Innovation Act (WIFIA) funding for Pacheco Dam through September 28, 2023, as well as all WIFIA loan application material. In the spirit of providing the response as quick as possible, the data pulled together was the same data provided in response to several public records act requests, and as such certain confidential information was redacted or excluded from public release based on external counsel advice. Examples include: records containing critical infrastructure information; data concerning financial identity; logins, passwords or other data associated with the security of data systems; and records of Native American graves, sacred places and objects. Substantive additional time would be necessary to pull together redacted/exempted information if that is desired, and per Board policy, would require Board approval to do so. 





Good Morning Ms. Hsueh,

I am writing to you this morning regarding the work on the Calabazas Creek that has been going on for the past several weeks.

Specifically, I am very concerned about the damage to my home and the homes of my neighbors resulting from the repeated pounding of long steel plates into the floor of the creek behind our homes. This technique causes our homes to shake and vibrate at each strike of the equipment. Bookcases and pots & pans rattle and the walls slightly sway.

When the crews began this process several weeks ago it was disturbing but it appeared it was only a brief episode that would be replaced by a different process that involved "drilling" into the soil rather than hammering the steel plates into the ground. We were told that this technique was required because overhead power lines prevented the use of the drilling equipment in the area directly behind our homes.

Since that time the "hammering" has occurred repeatedly and most recently last night from 6pm to 7pm and again at 7:23am this morning. This installation process is exposing our homes to even harsher pounding that is shaking our homes as though we are experiencing repeated earthquakes. In speaking with one of the workers last night, it appears that different equipment is being used to conduct this pounding that is more powerful because they are trying to move more quickly due to their approaching deadline and they acknowledge that shock wave resulting from their pounding.

I would note that the homes that are adjacent to the overhead power line have been exposed to the full impact of this process. We are older residents who are retired and home most of the day and have had to contend with the thought of how much damage is this work doing to our home.

I would hope that the Water District would take steps to address our concerns.

Any assistance that you can provide would be appreciated.

To whom it may concern,

As a student of Yerba Buena High School, I write to ask you to consider bringing up the issue of replacing the standard water sprinkler system at schools with a more efficient one. Being a resident of California, I am familiar with the constant droughts that the state has experienced. While water sources have recently been improving in the past year, weather conditions are still worsening, and the temperature levels are rising.

The current sprinkler system used in my school is one of the most wasteful ones. Spray irrigation heads have been known to lose up to 50% of water used due to evaporation and wind. This is a result of their excessively wide and tall ranges and the mist they produce. Even then, the sprinklers are set to activate quite often throughout the day and for long periods of time. This not only further wastes water, but overwaters the grass, sometimes even forming puddles that attract geese like a watering hole.

A much better alternative to this system are drip irrigation that are set to activate fewer times a day and for shorter periods of time. This would not only decrease the amount of water wasted but also the costs of how much the school would have to pay on the water bill. Decreasing the amount of water wasted would also benefit the state of California, in order to prepare for drought by saving water for the future, especially if more efficient water sprinkler systems were to be implemented in multiple Californian schools.

Dear Brigitte Rince,

Thank you for reaching out to Valley Water to share your concerns regarding the safety of the unsheltered individuals living in encampments along Guadalupe River adjacent to Highway 85. Valley Water and City of San Jose are currently negotiating development of an Emergency Interim Housing (EIH) site on the undeveloped 2.52-acre lot along Cherry Avenue. During the San Jose City Council meeting held on June 6, 2023, the City Council approved staff's recommendation to pursue the Cherry Avenue site for Emergency Interim Housing development and the Water Resources Protection Zone (WRPZ) which will be an identified zone to keep clear of camping, fires, damage to vegetation, wildlife, and pollution to the water. The WRPZ was approved in concept by City Council, but the actual formation needs to occur via an Ordinance, along with approval of the EIH project and the lease. The clear intent of the City Council is to create the WRPZ in collaboration with Valley Water and to house the unsheltered individuals living along this stretch of waterway. To address your concerns regarding flooding safety of unsheltered individuals, prior to inclement weather periods outreach teams across the county reach out to the unsheltered individuals living along waterways to share information about inclement weather shelters and other resources. Santa Clara County coordinates with these outreach teams and has increment weather criteria that they follow. More information on Storm Safety at the County's Office of Emergency Management can be found at https://emergencymanagement.sccgov.org/storm-safety

We recognize the unhoused and encampment situation in our county, region, state, and nation, remains an ongoing societal issue that we must strive to resolve together. Valley Water is in constant coordination with the cities, the County of Santa Clara and local law enforcement, to address encampment concerns.

Valley Water performs large-scale trash cleanups throughout the county to minimize trash generated by encampments that pollute the waterways. In this reach of Guadalupe River, Valley Water staff has already removed 74.18 tons of trash generated from encampments in this reach

of creek this past year, the last cleanup occurred on August 14 - 16. We also wanted to alert you to the upcoming encampment cleanup event in this reach on October 16, 2023, which hopefully will address your trash related concerns. Additionally, Coastal Cleanup Day was September 23, 2023, which also aims to address trash related concerns in this area and countywide.

We share your frustration regarding the impacts of the encampments and acknowledge the multi-agency process involved to address this issue can be extensive.

While Valley Water is committed to using the power that we have as an environmental stewardship agency to protect our waterways in collaboration with the cities and the county, as they fulfill their public safety and social service roles—Valley Water, as with all public agencies, must adhere to related case law and federal public health guidance.

Legal Constraints

Covid related: During the COVID-19 pandemic, the Centers for Disease Control and Prevention (CDC) issued interim guidance to public agencies, recommending they allow people who are living unsheltered or in encampments to remain where they are if no individual housing options are available due to the risk of spreading the disease. As of November 2022, this CDC guidance was updated to state that although people experiencing unsheltered homelessness do not reside in a congregate setting, the risk of severe COVID-19 can be high in this group because of underlying medical conditions and lack of access to healthcare.

Unhoused Case Law: Additionally, per the case of *Martin v. Boise*, the U.S. Court of Appeal for the Ninth Circuit held that the City of Boise violated the Eighth Amendment of the U.S. Constitution (prohibiting cruel and unusual punishment) for enforcing two city ordinances that made it a misdemeanor to camp on streets, sidewalks, parks, or public places (camping ordinance), or to sleep in a public place without the owner's permission (part of a disorderly conduct ordinance) when there was not enough beds available in local homeless shelters to house all of the unsheltered.

Effects of the Law on Valley Water

Both the case law and CDC guidance have significantly affected how public agencies like Valley Water are responding to encampments of unsheltered persons. Please note these constraints also apply to the City of San Jose's trails rules; so, while it is important to maintain public access to safe recreation opportunities, enforcement of these rules and ordinances on the unhoused community is subject to the limitations imposed by caselaw and statute.

Prior to the COVID-19 pandemic, Valley Water's approach to encampment management was a complaint-driven, abatement-focused strategy. While this approach addressed the immediate location of an encampment, it rarely led to an outcome of fewer encampments, and often the encampment moved to a new location. The new encampment management strategy seeks to manage encampments by using a variety of tools and approaches to better manage sites and reduce the need for abatements overall until adequate housing is available.

When performing work critical to its core mission, Valley Water will safely relocate encampments on Valley Water property including Valley Water right of way through coordinated efforts with other public agencies if the following criteria are met:

- a) the encampment is in the path of, interferes with or obstructs access to,
 - i. flood protection/ water infrastructure facilities or projects
 - ii. maintenance projects, facilities, or maintenance access roads
 - iii. designated mitigation or vegetation management sites
- b) the encampment poses an immediate safety risk— An immediate safety risk is one that involves safety of Valley Water staff. Safe relocation of encampments may also be

conducted in response to public safety issues as determined by local jurisdictions such as a city, the county, or their police or fire departments. In the case of a public safety issue Valley Water will assist local jurisdictions in addressing encampments on property where Valley Water holds land rights.

Everyone is still encouraged to contact the police if any illegal activity or threat to public health and safety is observed; and contact the fire department for fire and smoke incidents.

What Valley Water is Planning

Also, to address the long-standing issues related to unsheltered encampments, Valley Water's Board of Directors directed staff on January 18, 2023, to proceed with the following actions to address the human, environmental and operational concerns of encampments of unsheltered people in the riparian corridors of Santa Clara County:

- 1. Proceed with a District Act amendment to give the legal authority for Valley Water to address encampments of unhoused people separately, or in conjunction with a proposed District Act bill.
- 2. Develop a longer-term solution in global partnership with cities, the County, and other special districts to help ensure better outcomes for unsheltered people. This may take the form of a global agreement, a JPA, or the creation of a continuum of care in Santa Clara County.
- 3. Consider district owned properties that could be used for the development of housing and create an inventory of those properties.

Again, we want to assure you that Valley Water is actively working in concert with our agency partners and the community to address the unhoused and encampments. We are always appreciative of your comments and should you have additional concerns, please feel free to contact me directly.



Dear Director Huseh, I am writing this letter to your office following the direction of Kristine Zanardi from County Supervisor Simitian's Office.

The residents of Via Regina road in Saratoga <u>need urgent help</u>. The atmospheric river rain storms of this past January and February caused Calabazas Creek to flood over its channel banks in the hillsides adjacent to Via Regina and carve away critical hillside support to our road.


Three previously curve shaped channel areas that facilitated the creek flowing downstream were eroded into dagger shaped bulges which now capture the water flow forcing it deeper into the hillsides. If unchecked in the next major storm Calabazas Creek is <u>very</u> likely to sever Via Regina in two places stranding approximately 80 residents with <u>no way to access or leave their homes or to access / receive emergency services.</u>

Calabazas Creek flows under Via Regina about 500 feet from Pierce Road. The erosion to Via Regina's supporting hillsides resulted from severe unmitigated flooding from Calabazas Creek as it flowed through a series of privately owned neighboring parcels. We have been searching, thus far in vain, to secure assistance in repairing the carved out creek embankments before the major rains forecast for this winter completely sever the road. Valley Water, the agency we believe is responsible for flood control of the creeks and streams in Santa Clara County, has declined responsibility for repairing this erosion damage. We ask your urgent help in securing flood control repair support before further flooding severs our road.

Via Regina is a publicly accessible half mile mile long dead end road in the City of Saratoga hillsides accessed from Pierce Road. It is not City of Saratoga owned or maintained. None of the Via rebgina residents, nor any other functioning entity, have the organizational structure, personnel and means to deal with this danger.

I am including photos below of the two major erosion carve outs that most endanger our road.

Please contact me if I can be of any assistance in expediting repairs. I thank you in advance for your attention and help.

Dear Kathleen O'Connell,

Thank you for reaching out to Valley Water to share your concerns regarding encampments along Guadalupe River adjacent to Highway 85. Valley Water and City of San Jose are currently negotiating development of an Emergency Interim Housing (EIH) site on the undeveloped 2.52-acre lot along Cherry Avenue. During the San Jose City Council meeting held on June 6, 2023, the City Council approved staff's recommendation to pursue the Cherry Avenue site for Emergency Interim Housing development and the Water Resources Protection Zone (WRPZ) which will be an identified zone to keep clear of camping, fires, damage to vegetation, wildlife, and pollution to the water. The WRPZ was approved in concept by City Council, but the actual formation needs to occur via an Ordinance, along with approval of the EIH project and the lease. The clear intent of the City Council is to create the WRPZ in collaboration with Valley Water.

We recognize the unhoused and encampment situation in our county, region, state, and nation, remains an ongoing societal issue that we must strive to resolve together. Valley Water is in constant coordination with the cities, the County of Santa Clara and local law enforcement, to address encampment concerns.

Valley Water performs large-scale trash cleanups throughout the county to minimize trash generated by encampments that pollute the waterways. In this reach of Guadalupe River, Valley Water staff has already removed 74.18 tons of trash generated from encampments in this reach of creek this past year, the last cleanup occurred on August 14 - 16. We also wanted to alert you to the upcoming encampment cleanup event in this reach on October 16, 2023, which hopefully will address your trash related concerns. Additionally, Coastal Cleanup Day was September 23, 2023, which also aims to address trash related concerns in this area and countywide.

We share your frustration regarding the impacts of the encampments and acknowledge the multi-agency process involved to address this issue can be extensive.

While Valley Water is committed to using the power that we have as an environmental stewardship agency to protect our waterways in collaboration with the cities and the county, as they fulfill their public safety and social service roles—Valley Water, as with all public agencies, must adhere to related case law and federal public health guidance.

Legal Constraints

Covid related: During the COVID-19 pandemic, the Centers for Disease Control and Prevention (CDC) issued interim guidance to public agencies, recommending they allow people who are living unsheltered or in encampments to remain where they are if no individual housing options are available due to the risk of spreading the disease. As of November 2022, this CDC guidance was updated to state that although people experiencing unsheltered homelessness do not reside in a congregate setting, the risk of severe COVID-19 can be high in this group because of underlying medical conditions and lack of access to healthcare.

Unhoused Case Law: Additionally, per the case of *Martin v. Boise*, the U.S. Court of Appeal for the Ninth Circuit held that the City of Boise violated the Eighth Amendment of the U.S. Constitution (prohibiting cruel and unusual punishment) for enforcing two city ordinances that made it a misdemeanor to camp on streets, sidewalks, parks, or public places (camping ordinance), or to sleep in a public place without the owner's permission (part of a disorderly conduct ordinance) when there was not enough beds available in local homeless shelters to house all of the unsheltered.

Effects of the Law on Valley Water

Both the case law and CDC guidance have significantly affected how public agencies like Valley Water are responding to encampments of unsheltered persons. Please note these constraints also apply to the City of San Jose's trails rules; so, while it is important to maintain public access to safe recreation opportunities, enforcement of these rules and ordinances on the unhoused community is subject to the limitations imposed by caselaw and statute.

Prior to the COVID-19 pandemic, Valley Water's approach to encampment management was a complaint-driven, abatement-focused strategy. While this approach addressed the immediate location of an encampment, it rarely led to an outcome of fewer encampments, and often the encampment moved to a new location. The new encampment management strategy seeks to manage encampments by using a variety of tools and approaches to better manage sites and reduce the need for abatements overall until adequate housing is available.

When performing work critical to its core mission, Valley Water will safely relocate encampments on Valley Water property including Valley Water right of way through coordinated efforts with other public agencies if the following criteria are met:

- a) the encampment is in the path of, interferes with or obstructs access to,
 - i. flood protection/ water infrastructure facilities or projects
 - ii. maintenance projects, facilities, or maintenance access roads
 - iii. designated mitigation or vegetation management sites
- b) the encampment poses an immediate safety risk— An immediate safety risk is one that involves safety of Valley Water staff. Safe relocation of encampments may also be conducted in response to public safety issues as determined by local jurisdictions such as a city, the county, or their police or fire departments. In the case of a public safety issue Valley Water will assist local jurisdictions in addressing encampments on property where Valley Water holds land rights.

Everyone is still encouraged to contact the police if any illegal activity or threat to public health and safety is observed; and contact the fire department for fire and smoke incidents.

What Valley Water is Planning

Also, to address the long-standing issues related to unsheltered encampments, Valley Water's Board of Directors directed staff on January 18, 2023, to proceed with the following actions to address the human, environmental and operational concerns of encampments of unsheltered people in the riparian corridors of Santa Clara County:

- 1. Proceed with a District Act amendment to give the legal authority for Valley Water to address encampments of unhoused people separately, or in conjunction with a proposed District Act bill.
- 2. Develop a longer-term solution in global partnership with cities, the County, and other special districts to help ensure better outcomes for unsheltered people. This may take the form of a global agreement, a JPA, or the creation of a continuum of care in Santa Clara County.
- 3. Consider district owned properties that could be used for the development of housing and create an inventory of those properties.

Again, we want to assure you that Valley Water is actively working in concert with our agency partners and the community to address the unhoused and encampments. We are always appreciative of your comments and should you have additional concerns, please feel free to contact me directly.

Dear Michael Chau,

Thank you for bringing this important matter to our attention and for your commitment to water conservation. Valley Water understands that improving outdoor water use is essential to meeting our long-term water conservation goals and offers a suite of resources to assist schools like Yerba Buena, as well as businesses and residents throughout Santa Clara County be more efficient. From what you have described, the campus would likely benefit from the following programs:

- Landscape Survey Program: The free survey evaluates the current irrigation system and landscape water management practices and provides recommendations for improving system efficiency. These may include upgrading irrigation hardware, and/or providing the site with a calculated irrigation budget based on climate, irrigation system components, and vegetation. Yerba Buena has already taken a great step toward water conservation by being enrolled in the Waterfluence program which provides appropriate site stakeholders insight into the school's irrigation efficiency by comparing the actual amount of water used in the landscape to a customized budget.
- <u>Landscape Rebate Program</u>: We offer up to \$100,000 per site to upgrade inefficient landscapes and irrigation to high-efficiency alternatives. This includes converting high water-using lawns to climate-appropriate landscapes, irrigation equipment upgrades such as smart irrigation controllers, high-efficiency sprinklers and in-line drip irrigation, and rainwater capture.

Valley Water is also working to develop relationships with school districts throughout our county to encourage them to use water more efficiently and take advantage of our water conservation programs. Our staff will reach out to Yerba Buena High School and East Side Union School District to encourage them to participate. We will use our usual contacts at the schools, but if you have an additional contact that could help champion these efforts, please let our staff know.

Valley Water's water waste team responds to reports of water waste and violations of local water use restrictions. We encourage you to continue reporting water waste through the following options:

Additionally, Valley Water has a very robust Education Outreach Program that goes into the classrooms to teach students about various environmental stewardship issues, including water conservation and pollution prevention. If you are interested in having our staff present at your school, please ask your teacher to complete this <u>request form</u>.

We also have a very active Board Advisory Youth Commission that works on water related issues impacting young people in Santa Clara County. During the extreme drought period, the Youth Commission developed a

youth-centric Drought Awareness Toolkit to better engage young people to take action to conserve water and help spread the message. You can learn more about the Youth Commission and the Drought Awareness Toolkit here.

To whom it may concern,

As a student of Yerba Buena High School, I write to ask you to consider bringing up the issue of replacing the standard water sprinkler system at schools with a more efficient one. Being a resident of California, I am familiar with the constant droughts that the state has experienced. While water sources have recently been improving in the past year, weather conditions are still worsening, and the temperature levels are rising.

The current sprinkler system used in my school is one of the most wasteful ones. Spray irrigation heads have been known to lose up to 50% of water used due to evaporation and wind. This is a result of their excessively wide and tall ranges and the mist they produce. Even then, the sprinklers are set to activate quite often throughout the day and for long periods of time. This not only further wastes water, but overwaters the grass, sometimes even forming puddles that attract geese like a watering hole.

A much better alternative to this system are drip irrigation that are set to activate fewer times a day and for shorter periods of time. This would not only decrease the amount of water wasted but also the costs of how much the school would have to pay on the water bill. Decreasing the amount of water wasted would also benefit the state of California, in order to prepare for drought by saving water for the future, especially if more efficient water sprinkler systems were to be implemented in multiple Californian schools.
