

CAPITAL IMPROVEMENT COMMITTEE MEETING

- The Committee requested that staff communicate with the Federal agency that provided funding for the lower Silver Creek project relating to possible funding of the South Babb Flood Protection project.
- The Committee requested that staff provide a list of partially unfunded projects to the Committee.
- The Committee requested that staff include in its analysis the various topics, which include capital and non-capital projects, listed by Director Beall, including Los Gatos Creek at San Tomas, Sunnyoaks Percolation Ponds, Almaden Lake, Canoas Creek in the Martial Cottle Park area, various groundwater projects, the Water Purification Program, projects involving bridges, and Lake Cunningham.
- The Committee requested that staff include references to new investments in external capital opportunities in the CIP.
- The Committee requested a list of capital investments already made and projected investments relating to new projects in the Water Supply Master Plan.
