

## ANNUAL OPEN ENROLLMENT INFORMATION

Valley Water's Benefits & Wellness Program is holding the annual open enrollment for all SCVWD (Valley Water) retirees from **September 29, 2025, through October 17, 2025**, for a **January 1, 2026, effective date**.

Open Enrollment is your opportunity to:

- **Change, enroll, or drop medical plans**
- **Add or delete eligible dependents**

If you are **NOT** making any changes to your existing benefits, no further action is required unless you wish to drop Valley Water's medical coverage for you and/or your dependents.

**If you would like to enroll OR opt-out from the Anthem Medicare Advantage plan, please call RetireeFirst Advocates at (408) 868-8964 (TTY 711) or toll free (855) 301-8203 (TTY 711) Monday-Friday, 8am - 5pm PST.**

If you are making changes (i.e. switching from Kaiser to Blue Shield PPO, adding a dependent or deleting a dependent), you will need to complete the applicable forms. Either:

The effective date for any benefit changes submitted during open enrollment will be **January 1, 2026**.



Other than life status event(s), open enrollment is the *only* time you can make changes to your benefit plans. For a life status qualifying event, such as marriage, birth, adoption, loss of other coverage, etc., you have up to **30 calendar days from the date of the qualifying event date** to enroll any eligible dependents. No late changes can be accepted per the IRS and insurance carrier regulations.

**When a dependent is no longer eligible for coverage due to a life status change, such as divorce, death or a child ceases to no longer be considered an eligible dependent, it is imperative that you notify the Benefits & Wellness Program at [EmployeeServices@valleywater.org](mailto:EmployeeServices@valleywater.org) or (408) 630-3030 within 30 calendar days of the event. Failure to notify Valley Water in the appropriate timeframe may constitute tax/insurance fraud. If an ineligible dependent receives treatment, you will be held liable for charges incurred.**

### **Personal Information Changes**

As a reminder, if your address/phone number should change, it is important to notify Valley Water's **Benefits & Wellness Program** at [EmployeeServices@valleywater.org](mailto:EmployeeServices@valleywater.org) or (408) 630-3030 so that your Valley Water records can be updated.

**All open enrollment changes must be submitted to Valley Water's Benefits & Wellness Program NO LATER THAN Friday, October 17, 2025**
