Wake New Hope Fire Department History

- Wake New Hope Fire Department was started in 1956
- Wake New Hope Station 1 at 4415 St. James Church Road Fire Station opened and began service in 1958



Wake New Hope Fire Department Current Coverage

- Wake New Hope Fire Department
 Fire Station 1 service area has
 changed dramatically from the 1960s
 through 2022
- Most of this area has been annexed by the City of Raleigh, leaving small pockets of unincorporated areas of land and homes
- Less than 5 square miles remain for New Hope Station 1 to cover

Areas in tan are Wake New Hope county areas

Past Studies: 1994 Tri Data Study – Page 10 Executive Summary

The cities of Raleigh and Cary should be encouraged to expand their service delivery areas for fire protection and other emergency services to include all of the surrounding unincorporated areas where their municipal career fire departments can respond most quickly. This would form a band around the two cities to encompass all of the fragmented areas that have been created by annexations. The main objective of this plan would be to provide the primary emergency response to these areas from the closest available fire station(s). If a single fire district plan is not adopted, the unincorporated areas that would be served by the two major fire departments should be consolidated as two fire districts; an expansion of the Raleigh Suburban Fire District and a new Cary Suburban Fire District.





Station Closure Results



Consider supplemental documents such as Community Engagement Study, IRTE/ORED Documents as well as older applicable studies in future decision-making opportunities regarding Stations and Staffing.

Proposed Area: By the Numbers

- 1,224 occupied units
- Population of 3,280
- 4.69 square miles
- Property value estimated at \$489,804,789
- 247 Fire/EMS calls in calendar year 2020
- Five Raleigh Fire Department stations within five miles

Current Service Delivery Model

Response for all areas within unincorporated Wake County is based on closest available unit with response rules built into the CAD (4 minutes 30 second rule for travel times into and outside of Raleigh municipal limits)




- Example 5808 Dean Drive is an address in the unincorporated area of Wake County in one of the "donut holes"
 - GIS Travel Time Modeling shows that Raleigh E19 can be there within 1.31 minutes and Wake New Hope E1 would take 3.91 minutes.
- Exceptions to the CAD rules structure fires, cardiac events and vehicle accidents with severe injuries a 30 second rule is applied.

Obstacles

- Unknown ISO implications for Raleigh
- Pride and tradition of existing departments





New ruling from the NC Department of Insurance




If a Fire Departments primary fire district has an area **over** five miles from their station or stations but the neighboring fire district has a fire station within five miles of that same area, then automatic aid for station location for that area can be applied. By applying this automatic aid area, the property owners will then receive the primary fire districts five-mile district rating.

Removes one obstacle

 Raleigh covering county district within five miles of their stations under auto aid does not affect their ISO grade

New Hope Station 1




White - City of Raleigh

Proposed Service Delivery Model

Raleigh Fire Department response plans would apply to area within the Wake New Hope Fire Insurance District that are outside of 5 road miles from Wake New Hope Station 2



- Example 5808 Dean Drive is an address in the unincorporated area of Wake County in one of the "donut holes"
 - GIS Travel Time Modeling shows that Raleigh E19 can be there within 1.31 minutes and Wake New Hope E1 would take 3.91 minutes.
 - On structure fire related calls, the Raleigh Fire Response Plan would also get a Wake New Hope Engine & County Tanker Response


New Partnership


Proposal

- Multi-year North Carolina
 Department of Insurance-approved auto aid agreement for Fire and EMS service delivery
- Areas that are more than five miles from Wake New Hope Station 2 will receive a City of Raleigh Fire Department response
- Service transfers on July 1, 2022
- Current Wake New Hope Fire
 Department personnel resources will be moved to Station 2



Testing

• On or near June 1, 2022, we will begin testing of the new Raleigh response plans for the district to ensure a smooth transition of services on July 1.





Summary



- Complete a Service Level Auto Aid Agreement between the City of Raleigh, Wake County and Wake New Hope Fire Department for Fire/EMS services in existing Wake New Hope Fire Departments district more than five miles from existing Station 2
- Proposed start date of July 1, 2022
- This does NOT make residents within this area
 City of Raleigh taxpayers
- The reallocation of resources to Wake New Hope Station 2 will strengthen Wake County's overall response plan for eastern Wake County
