1. Question: Is there more details on the existing windows for the new roller shades? Ie. Dimensions (H&W) and recessed depth?

Response: It is the responsibility of the contractor to field measure window dimensions.

2. Question: Will General Contractor be supplying the new blinds?

Response: Yes, the General Contractor is responsible to demolish the existing window blinds and supply and install new window shades in Suites A and B. See DEMOLITION KEY NOTES – FLOOR PLAN no. 4 and GENERAL KEY NOTES no. 1.

3. Question: On the fireproofing repair allowance, it shows for 50 units, does the unit price need to reflect that or does it need to reflect 1 SF?

Response: The Unit Price shall reflect (1) one square foot. See BID DOCUMENTS Items 1 and 2 above for additional information.

1.1 RELATED DOCUMENTS

1.3 DEFINITIONS

A. Unit price is an amount incorporated in the Agreement, applicable during the duration of the Work as a price per unit of measurement for materials, equipment, or services, or a portion of the Work, added to or deducted from the Contract Sum by appropriate modification, if the scope of Work or estimated quantities of Work required by the Contract Documents are increased or decreased.

1.4 PROCEDURES

- A. Unit prices include all necessary material, plus cost for delivery, installation, insurance, applicable taxes, overhead, and profit.
- B. Measurement and Payment: See individual Specification Sections for work that requires establishment of unit prices. Methods of measurement and payment for unit prices are specified in those Sections.
- C. Owner reserves the right to reject Contractor's measurement of work-in-place that involves use of established unit prices and to have this work measured, at Owner's expense, by an independent surveyor acceptable to Contractor.
- D. List of Unit Prices: A schedule of unit prices is included in Part 3. Specification Sections referenced in the schedule contain requirements for materials described under each unit price.

 - 2. Unit of Measurement: Each.
 - 3. Allowance Quantity: Coordinate unit price with allowance adjustment requirements in Section 012100 "Allowances."
- B. Unit Price No. 2: Wall or Ceiling mounted Exit Light.
 - Description: Provide one Wall or Ceiling mounted Exit Light and circuit. Unit price shall include 50 LF of wiring and conduit and all materials and labor for complete installation
 - 2. Unit of Measurement: Each.
- C. Unit Price No. 3: 20 amp Electrical Duplex Receptacle and Circuit.
 - Description: Provide one 20 Amp electrical duplex receptacle and circuit. Unit price shall include 90 LF of wiring and conduit and all materials and labor for complete installation.
 - 2. Unit of Measurement: Each.
- D. Unit Price No. 4: Data drop.
 - Description: Provide one data drop device box at 18 inches AFF and one 1" conduit to above lay-in ceiling. Unit price shall include all materials and labor to complete installation.
 - 2. Unit of Measurement: Each.
- E. Unit Price No. 5: Fireproofing Repair.
 - 1. Description: Provide repair of 1 square feet of the existing fireproofing at the roof deck. The unit price shall include all materials, labor, equipment, and access to the roof deck to complete the installation.
 - 2. Unit of Measurement: 1 Square Foot.
 - 3. Allowance Quantity: 50 Square Feet. Coordinate unit price with allowance adjustment requirements in Section 012100 "Allowances."
