
How to Apply Online for Individual Lot Stormwater (Deviation)

CSS: Online permitting for Watershed Management Go to the Permit Portal

Step One: Register. You will create a user name and password. [Engineering Firms are encouraged to create a user name for the Firm rather than the individual that all employees can share]

Step Two: Login

You will see your Dashboard of Permits, Plans, and Inspections.




Step Three: Apply for a Permit. Click on **Apply**. Click on **Permits**. Then click on All
